Who May Vote at District Meetings;

Rules Governing.

Any citizen of this state, male or female, who is twenty-one years of age, and has been a bona fide resident of the district for thirty days immediately proceeding the meeting or election, and has real property in the district, the title of which is in her or his own name, on which he or she is

liable or subject to pay tax, shall be entitled to vote at any district road meeting. In all other regards the laws of this state governing school district meetings shall control at all road district meetings.

Road District; Special Tax. The resident taxpayers of any road district in any county of the state may vote an additional tax not to exceed ten mills on the dollar on all taxable property of the road district, if the county court shall first approve such additional tax by indorsement to that effect upon the petition for a road district meeting to be held for that purpose

Meetings for the purpose of voting additional taxes in road districts shall be held in the month of November.


