What the Editors Say

The Young Men's Christian Association has been severely reprimanded by the American public for negligence during the war that it has rushed into print in self defense, sending the newspapers of the country prepared articles giving its side of the story. The retirement of Miss Jeanette Rankin of Montana as a congresswoman does not augur well for the continuation of the practice of electing women to the highest law-making body in the land. Whether men fear being sidetracked by the women in legislative halls or whether they prefer to have them queens of the household is conjectural, but it must be an admitted fact that she graces the latter place best, and that the proper rearing of children is primarily her first duty, else the race will perish.—Telephone Register.

The school board is up against a serious proposition this year in trying to conduct the schools within the limit set by the taxpayers in the budget adopted last June. The estimates then made by the board for teachers salaries were based upon the advance of ten dollars a month granted last year. The legislature has upset all this and has established a minimum salary, which is about sixteen per cent higher than was anticipated. This will make a deficit in the district funds that can not be overcome, even by the most rigid economy.—Sheridan Sun.

The socialists swear Eugene Debs will be liberated from jail. Why not? The administration has seen fit to give the conscientious objector a fine "handy-me-down" and a nice, snug little bonus, those who were brazen enough to violate the espionage act have been politely condoned and that prince of "patriots"—the slacker—has been robed in a garment of white and turned loose to gambol and frisk about the green pastures while thousands of our boys who have only been in the front line trenches and dodging sharpnel on the border of "No Man's Land" are given the same sixty bones—minus the condolent and spotless garments.—Umpqua Valley News.

A bright and shining example of legislation which is too common is the provision of the election law which requires the sending of notices to registered voters who fail to vote before removing the name from the list. Most states place the burden on the voter and failure to vote for a certain period means removal of the name. Most of those who did not go to the polls last year know it without being reminded. Had the law said their names would be dropped they would also have known it and would have registered before attempting to vote. But following its custom of ignoring cost the Oregon law places the burden on the public, and county clerks are now sending out the required notices. Clerical help, stationery and postage will aggregate a large sum which might have easily been saved.—Independent.

Many of the farmers in Yamhill County are naming their farms. There are a number of things which will lend themselves to suggest the selection of an appellation for a farm. Its land or water, its trees or historical relation adopt themselves to the choice of an appropriate name. There was those who favor Indian names. When the farm is named and the appellation has been duly registered with the county clerk, the next thing to do is to have some neat stationery printed. Then you can begin to advertise the produce which you think will bring you the most profit. Hundreds of farms have been named in Yamhill county, and many of them have emblazoned the name at the main entrance gate to the place. It gives the farm a dignified air and shows that the owner is proud of his premises and of the things he produces. Moreover, the name of the farm on a box of apples, on a sack of potatoes, on a berry crate, on a roll of butter, acts as a trade mark. If the produce is of good quality, the purchaser will remember the name and will ask for it again.—News Reporter.

Germany Will Bear Close Watching.

A menacing note is heard in the protesting statement of Mathias Erzberger, head of the German armistice commission. He is quoted as having publicly declared that if the allies load the peace treaty with conditions going beyond President Wilson's 14 points the German national assembly will refuse to ratify the settlement. That obviously is an intimation that the German government intends to put its own construction on the president's language. Erzberger goes so far as to raise a question over the return to France of Alsace-Lorraine, and to declaim any responsibility upon Germany to pay compensation for lawless acts she committed after her first peace offer of 1916. He speaks defiantly of the "malted fist policy of the allies," and in other ways indicates a purpose to alarm the allies with bluff and bluster. This arrogant attitude should spur

up the peace congress to hasten the delivery of its ultimatum to the Germans. It is plain that the old military forces in Germany construe the long delay at Paris as indicative of stubborn differences in the councils of the allies. Every added day of the protracted conferences tends to strengthen that thought in the German mind and to increase the danger that Germany may become defiant and reject the settlement, leaving the allies in the dilemma of moderating their demands or threatening the enemy with renewal of warfare.

Unfortunately evil forces even now are plotting in Germany for a resumption of hostilities. The Hohenzollerns and the whole junker element are desperate and must be watched closely. The gambler who plays for high stakes and loses is eager for another chance at fortune and the military gamblers in Germany are no exception to the rule. They will outwit the allies if possible.—Spokesman Review.

Paving Marion County.

One hundred miles of market road pavement for Marion County, to be laid during five years, is a program upon which the Roads Committee, Taxpayers' Committees and Grange Committees have substantially agreed. A county bond issue of \$840,000 is involved. The roads would be paved by the county court instead of by contract. As none of the roads would have heavy truck traffic, it is expected that a lighter quality of paving laid by the county court would stand up. The paving laid by the county court in Marion county during the last four years has stood up fairly well, and has proven of inestimable benefit to the districts reached. It totals only a few miles, however—just a mile or two on each of the different roads leading out of Salem. Light as the paving is, compared to a first class quality, it has been of great benefit, and the county likes the idea of getting more of it. The fact that the different interests of the county, hitherto conflicting, have gotten together on the preliminaries of this plan is a good sign. Heretofore these interests have been at swords' points. The kind of paving laid by the Marion County Court, while far from the solidist, is a whole lot better than none and a whole lot cheaper than none, considering the cost of keeping gravel or macadam roads in condition.

With a hundred miles of paved market roads in the county, Old Marion will develop rapidly. The loganberry industry has made wonderful strides there, but its success is limited to road conditions. With more paving, there will be more loganberry production. This will mean not only happier and more contented farmers, but heavy increase in property values and in tax returns. With Marion County united on a good road program, there would seem to be no limit to what would be accomplished in any part of Oregon.—Oregon Voter.

SOLDIER SENSUS TO BEGIN.

Papers Received With Which to Compile Record.

County Superintendent Lamb has received the printed matter to be used in compilation of the list of men who entered the army and navy from Tillamook county and is this week sending out a letter to school districts, it having been decided that the principal teacher and members of the board will have charge of the work. Questionnaires will be furnished and families with relatives who entered the service will be asked to fill out a separate blank for each man in the army or navy. The work is important for the reason that only in this way can accurate record be made. War department records often do not give the county to which enlistments should be credited, and in the case of a large number of Tillamook county men who volunteered early in the war the enlistment is credited to Portland, where the recruiting office was located. Miss Vornelia Marvin, state librarian has been placed in charge of the work and when completed it will form a permanent state record at Salem and will be of great value in the future. In the interest of accuracy and that no omissions be made cooperation of all parents and other relatives of soldiers and sailors is urgently requested, but all that they will be asked to do is to fill out the blanks that will be supplied and see that they are returned to the person authorized to receive them. As an illustration of the importance of the record it might be said that at present it is not definitely known just how many Tillamook county men entered the service, estimates varying widely. The number of men furnished by the selective service can of course be learned, for the records are complete, but there is no record of the large number of voluntary enlistments.
