Editorial Snap Shots.

Maybe it wouldn't be a bad idea for the Tillamook County Creamery association, now that it is going to stage another advertising stunt, to favor the Headlight with some of the advertising.

It is certainly amusing to read what some of the statesmen in Germany are saying about the terms of peace, for they claim they want justice and are being imposed upon by the peace conference.

No doubt Germany finds it a bitter pill to swallow, for instead of collecting that great big indemnity it figured upon collecting from the United States it will have to cough up about fifty billion dollars.

It is gratifying to know that the treaty of peace will be ready by the 1st of May, when the German delegation will be called in and another long pow-wow will be the order of business, for the Germans will put up a great whine and protest.

The allies made a great mistake when they agreed upon the terms of the armistice that it did not stipulate that the allied armies should occupy Berlin and Vienna. Germany is as arrogant as ever and does not believe that she is whipped.

This looks a little inconsistent. If it is necessary for persons to wear gauze masks on entering places of business and amusement, etc., we are inclined to think that, to be logical, persons visiting one another in their homes should also be compelled to wear masks, for it maybe that this is how the flu is being carried around.

General Ludendorff says it was the Franco-British offensive near Albert on August 8, 1918, which caused the Germans to lose heart and admit that that country could not hope to win a military victory. Those who remember the fierce fighting on the Franco-British sector along in the early part of August will not be surprised to hear of Ludendorff's admission, for the allies did pound away day after day and inflict serious losses on the German army, which knocked the pep out of the brutal, blood-thirsty Hun.

Somebody is talking through their hat when they make the statement that thousand of war worn motor trucks, which carried munitions and food supplies to the American soldiers at the front in France, will be repaired, and that the war department has already made plans to create a national system of transportation, for the purpose of bringing the products of the farm to the consumer. If the government does start that system it is safe to say that it will have a white elephant on its hands and will require large appropriations from Congress to pay the expenses. Government control of railroads and telegraph and telephone lines, which are costing the taxpayers millions of dollars, is a rank failure. Perhaps, however, there are another big bunch of Democrats who think that Uncle Sam owe them a living and a soft job running a transportation business.

The untimely death of Jesse C. Remick cast a cloud of gloom over the city when the sad news was received on Monday that he had been found dead that morning. It is only recently that the deceased came to Tillamook county, to engage in lumbering on a large scale, as the erection of the large sawmill at Garibaldi, at a great outlay of money, fully indicates. During Mr. Remick's residence in Tillamook he made himself most agreeable, and was beginning to take a lively interest in the affairs of the county, and he won the respect and admiration of the business men of this city and those who had the pleasure of his acquaintance. His death is a loss to Tillamook county, for he came fully determined to carry out big things in the lumber business. He was a big, broad minded business man and believed in co-operating with all parts of the county for mutual benefits. It is, therefore, with much regret and sorrow to his many friends that this fine gentleman has been taken away at a time when he was about to commence running a large saw mill on a large scale. We are sure we express the sentiments of the people of Tillamook in extending their sympathy to the bereaved widow and daughters.

Death of Frank Dye.

We are sorry to announce the death of Frank Dye, which occurred on Monday from the effects of influenza. He was road supervisor of road district No. 2. The funeral has been postponed for several days.

The deceased was born in Carrol County, Missouri, on the 3rd of October, 1880, and he moved to Tillamook county in 1909, living here until the time of his death April 7th. He was married to Miss Mary E. Tucker the first of July, 1906 and three children were born to the union viz, Jesse, aged 10; Mamie, aged 8; and Marvin aged 6 years. The deceased leaves a wife, three children, an aged father and mother, one brother Connie Dye, and one sister, Mrs. O. W. Kinnaman, besides other relatives, and a host of friends to mourn his death.

He was a member of the U. B. church at Beaver and was a consistent Christian, and was a member of the Oddfellows and Modern Woodmen lodges.

On Monday evening the City Council re-enacted the ordinance compelling everybody to wear gauze masks on entering business houses, offices, theatres, churches and places where meetings are held.

The school board closed the school Tuesday, one reason being that so many parents were not sending their children to school.

The management of the Gem Theatre closed down and will not re-open until the embargo is taken off. Church services will be suspended in the Allied Church next Sunday.
