**Notice of Intention to Improve Street in Tillamook City, Oregon.**

**NOTICE IS HEREBY GIVEN**, to all whom it may concern, that the Common Council of Tillamook City, Oregon, deeming it expedient to improve the street hereinafter described did, on the 14th day of April, 1919, adopt a resolution for said improvement, which said resolution is in words and figures as follows, to-wit: Resolution and Notice of Intention to Improve a Certain Street in Tillamook City, Oregon.

Be it resolved that the Common Council of Tillamook City, Oregon, deems it expedient and hereby declares its intention to improve the following street in said city, to-wit: All that portion of Seventh Street extending from the East side of Stillwell Avenue to the West side of Miller Avenue, by establishing the grade of said street; by grading the same to proper subgrade by rolling the roadway thereof by laying thereon a concrete roadway 24 feet in width and 6 inches in thickness; by building curbs, catch basins and laying drain pipe, together with inlets and constructing laterals for sewer connections, and making provision for the necessary surface drainage of said street with all the appurtenances thereto.

All of said improvements to be made in accordance with the charter, resolutions and ordinances of Tillamook City and in accordance with the plans and specifications and estimates of work therefor, made and prepared by the City Engineer of Tillamook City, Oregon, filed in the office of the City Recorder of said Tillamook City. All of said improvements to be made at the expense of the property and all thereof adjacent thereto and specially benefited by said improvements within the limits of the district established and defined by this resolution.

Be it further resolved, that the plans, specifications and estimates for the proposed improvements so made and prepared by the City Engineer as aforesaid, the estimate of the probably total cost thereof being the sum of \$14,676.59 be, and the same are hereby approved.

That the boundaries of the assessment district to be benefited by said improvements and assessed therefore are hereby established as follows:

Beginning at the Northwest corner of Lot 5, in block 2, of Central Addition to Tillamook City, being on the East side of Stillwell Avenue in Tillamook City, and running thence East to the West Side of Block 8 of A. A. Miller's Addition to the town of Tillamook (now Tillamook City,) running thence South to the center of the West side of said Block 8; thence east along the center line of said Block 8 to the East side thereof; thence South to the Southeast corner of Lot 1 in Block 10 of A. A. Miller's Addition to the Town of Tillamook (now Tillamook City) Oregon, and running thence West along the center line of said Block; to the East side of said Block; thence North to the center of the East side of Block 41 of Thayer's Addition to what is now Tillamook City; thence West along the center line of said Block 41, and other blocks lying West thereof, to the Southwest corner of Lot 4 in Block 2 of R.
