**Editorial Snap Shots.**

Will somebody please explain to us how a woman who keeps house can vote for a party that kept them out of sugar and made them pay exorbitant prices because President Wilson did not have the business sense to buy the Cuban sugar?

Our good friend, Ben Nunn, of the Reporter, say Wheeler leads and Tillamook follows. Wrong again Ben. The dairyman and lumber interests of this country, neither is Tillamook city, following the preaching of the free trade, democratic editor, as he will see when the votes are counted next month.

The Tillamook High school pupils who voted for Wilson's League of nations overruled the fact that the U. S. Senate ratified the covenant, they will be of draft age in four years and Babie to be called up to fight the battles of our punctilious European nations. Well, what's that they voted for, for article 14 of the League of nations bind the United States to take a hand in European brooks.

It was a little surprising in the straw vote taken in the business district of this city to find that quite a number of persons voted against the Wilson League covenant, and voted for Governor Cox, who is in favor of the Wilson League. That is one part with a person who voted for a republican president and then voted for a democrat for U. S. Senator. Some of our citizens need straightening out, politically.

The matter of harbor improvements for Nehalem and Tillamook bays is of far more importance than a large number of our citizens realize. The shortage of cars on the Southern Pacific railroad with increased freight rates should make everybody look up and take notice, and the proper solution is water transportation for the lumberman and the dairyman. This is something that this county must have.

It is pretty generally conceded that Senator Harding will be the next president. The next few years it will be necessary to obtain government assistance for the improvement of Tillamook and Nehalem bars and harbors. The men who are best able to obtain government aid are those who are politically connected with the administration. If Robert N. Stanfield, the republican nominee for U. S. Senator, is elected he will be in a position to demand improvements for the coast country, whereas, if a democratic Senator is elected he will have little or no pull with the administration. Anyone can see the logic of our contention, viz., that it is for the best interests of Tillamook county that Robert N. Stanfield be elected U. S. Senator.

Who said it rained 11 months in a year in Tillamook? It looks as though the Willmington valley is getting the same reputation. There is this difference, however, while the rain in the Willmington Valley destroyed considerable fruit, with a 10 per cent loss in the grower's crop, over in this neck of the woods Old Boys is getting such an enormous lot of green grass that it is growing faster than the dairy herds can eat it. So it does not hurt our feelings one bit by saying that it rains 11 months in the year in Tillamook, as rain has as much to do with the success of the cheese industry in this country as any other factor, in fact, is the one great factor, for without it dairying in this country would not amount to a whoop. The snap shot man only expresses the sentiment of every dairyman in the county when we say, "Let 'er Rain."

Rev. W. F. Anderson of Cincinnati, Catholic Episcopate, Bishop of

the area of Ohio and Kentucky, witnessed a storm of applause at the conference of his denomination at Sidney, Ohio, September 5, when, in declaring that President Wilson should have accepted the reservations to the peace treaty adopted by the United States Senate, he said: "I submit to you in the interest of Christian civilization and by virtue of the fact that the destiny of millions of men, women and children depended on the action of that hour, that is what ought to have happened. That is what would have happened if the President had really cared more about having his own particular way in the matter, because his natural and highly cultivated egotism stood in the way of that piece of world constructive statesmanship."

Albert W. Fox, writing in the Washington Post, indicates that Governor Cox has "killed the goose," so to speak. Mr. Fox says: "The greatest impediment to the flow of Democratic funds has apparently been Governor Cox's 'slush fund' charge against the Republicans. Democratic headquarters in New York sent 1,000 telegrams to wealthy Democrats throughout the country just before the governor launched his accusations. It was expected that hundreds of the governor's supporters would contribute \$5,000 or \$10,000 each. It virtually frightened the would-be Democratic contributors into withholding any and all unanticipated contributions. Instead of checks, Democratic headquarters received countless letters explaining that the writer had intended to contribute but did not want his name to appear in the newspapers in connection with the Senate's slush fund investigation."

The Headlight will compile election returns as usual for the November election, and we ask the co-operation of election boards and others who are able to expedite the returns from each precinct reaching us as quickly as possible. At the primary election our representatives met with cranky persons on the boards, which, no doubt, was caused by other persons other than the Press buzzing in and taking time and interfering with the count, to be used to attract a crowd at poll scenes. We are sure boards of election that our representatives will take up as little time as possible, and as the information is for the public, we feel sure each election board will allow the Press to obtain the figures at certain periods. The Headlight will also make arrangements to keep the people of this country also informed whether the party that kept us out of war on the republican party wins at the election.

It used to be that the leaders in the republican party in this country, and especially those who had been honored with nominations, would not interfere and carry on an aggressive campaign. The last few elections they have been so indifferent as to do as bad as a door mat, leaving the snap shot man to do the political scrapping. And they don't appear to have the energy and snap to even raise some small money or help keep the party that kept them out of war and spent the taxpayers' money like a lot of drunken democrats, no, we mean sailors. As competition, and opposition is the life of business, as well as politics, maybe it wouldn't be a bad idea to have a local democratic ticket in the field another year to make an election more interesting. But we don't approve of those who have been honored with nominations setting back in their offices and depend on the other fellow to do the work, as well as receive the hard knocks.

The Portland Spectator says: Political conditions in Oregon and California are somewhat similar. Here the registration records show twice as many Republicans as Democrats and we have a Democratic man, Gen. E. Chamberlain, representing us in the United States Senate; in California there are nearly three Republicans to one Democrat, and James D. Phelan, a democrat, is senator. The reason for this anomaly is that all who gather as Republicans on the registration records are not gold in the voting booth. A great many persons consider it more respectable to register as Republicans than as Democrats. Having gained whatever reputation for responsibility there is attached to their open registration as Republicans, these persons go to the ballot box and faithfully cast their votes for Democrats. Whether or not it is quite honest thus to claim responsibility through avowed affiliation with the Republican party, and then surreptitiously go vote against its principles and candidates is a question for the political chameleons to determine.

We are interested in the Brighten Mills Co., for a car of slate wood. That shows how one of our saw mills appreciates the home newspaper, and although we appear to be on the first list, the snap shot man is opposed to the democratic cause. He is a democrat with a republican president and a republican congress there is every prospect that lumber and dairy products will obtain more protection, for Hindu manufacturers, lumber and Chinese eggs should not be allowed to compete with the lumber manufacturers and the dairy products of Tillamook county. Those who want more Chinese eggs and Canadian lumber to come into the country should vote the democratic ticket, and those who want to protect the principal industries of this country will vote for Senator Harding, for President, R. N. Stanfield, the U. S. Senator and W. S. Hawley for congressman. Anyway, we do not think that a person who owns property or is in business here uses good sense to belong to and vote for the democratic party—pardon, we mean the one right party dominated by an amateur who kept us out of war.

Senator Harding is asking those who vote for him to vote of R. N. Stanfield for United States Senator is giving good advice to the Republicans of Oregon. All must admit that when Senator Harding becomes president next March he will have a tremendous job on his hand, for never before in the history of the United States were there so many serious problems to straighten out. The un-business system of the Wilson administration and with the whole country honeycombed with anarchists, the next republican administration is confronted with a condition that never should have been allowed to exist in a country like the United States. Therefore, it is highly important that Mr. Harding should have a republican senator from Oregon to help him, in this great undertaking that confronts the next republican administration. When you cast your vote for Harding, cast a vote for Stanfield also. The next congress should be in accord with Mr. Harding, but should the United States Senate be dominated by democratic, largely from the Southern states, it will be a serious handicap to the republican party in getting the country back to normal conditions.

So False Alarm Jimmy Cox put a sudden stop to money being subscribed for the democratic campaign. One may not believe it but it is a fact nevertheless, and that accounts for the report that the campaign managers will be deep in the hole when the campaign is over. It came about like this. False Alarm Jimmy wrongfully accused the republican managers of raising millions of dollars to buy the presidency. At breakfast time False Alarm Jimmy said it was \$8,000,000, at lunch time it was \$15,000,000, and by dinner time Jimmy Cox had multiplied it to \$30,000,000. Jimmy Cox next morning subtracted about half the amount, but by evening had it back where he had figured it the previous evening. The senate investigation committee found that False Alarm Jimmy was talking through his hat and for a political effect. Some of the big subscribers to the democratic campaign fund got cold feet and refused to "spoon up" for fear that they would be investigated. So Jimmy Cox, false alarm about republican slush money has put the democratic campaign managers in a quandary and brought about a frost at headquarters.

The appointment of T. E. Hanley in the office of Attorney General is a great honor conferred on one of our honored sons. It came as a surprise to Tillamook people when a telegram was received by Attorney S. S. Johnson telling the good news, and the people generally appeared to be well pleased. Mr. Hanley made good when he represented Tillamook and Yamhill counties in the lower house, and when he became state senator the Washington, Lincoln, Tillamook and Yamhill counties. It was these offices that brought him in judicial notice, having filled them with credit to himself and the counties he represented. Mr. Hanley, however, had declined the appointment, for the reason that he did not have the time and means to run a state wide campaign and where his name would have to be written on the ballot, with possibly candidates from large cities. To our way of thinking he did good discretion in putting the appointment down, for a great many questions are being asked why the resignations could not have taken place so as to allow persons names to appear on the ballot.

If other parts of Oregon vote in November the same as those who voted in the straw vote in this city, Harding will carry the state, by a vote of 3 to 1 and R. N. Stanfield will beat Senator Chamberlain, 2 to 1. As the democratic party is divided, with two democrats, Senator Chamberlain and Thomas A. Hayes running for United States Senator, our George is badly handicapped, with the republican party united. Why so many democrats are now opposed to Senator Chamberlain is because they claim he deserved the democratic administration when he was needed, having first voted for Wilson's league covenant and then voted for the Lodge resolution. When Senator Chamberlain was re-elected in 1918, there were over 200 republicans in the race, R. A. Booth, the regular republican nominee, and William Hawley, progressive republican. Booth polled 58,297 and Hawley 24,220, or a total of 82,517. Senator Chamberlain polled 113,761, which gave a republican plurality of 1,747. With conditions reversed this year, with two democratic candidates for U. S. Senator with a large number of influential democrats after the scalp of our George, he is doomed to defeat. And for the further reason that republicans see the wisdom of voting for both Senator Harding, for president, and R. N. Stanfield for U. S. Senator.

It is safe to predict that when the republican party is restored to power, one of the first things it will undertake will be to grapple with the unicameral element, and it is going to take radical measures to bring about better conditions. To our way of thinking, a vigorous campaign should be started to round up the foreign members who have come to the United States to preach their false doctrines in a new country, and after they have been rounded up we immediately send them back to their own countries, never to return. We also propose to take a retrospective view of the present democratic administration and it must be admitted that scarcely increased more in the one year than in any other period of the United States. We want to say that a serious state of affairs exists throughout the country when men will stamp so low in rating in the United States that they will vote for a disreputable citizen like Debs for president of United States. 
