






"The village represents a true community spirit and has been the means of promoting a better understanding between various classes by arranging that people with different sizes of income may live on the estate. It is not a charity enterprise. It is self supporting and has made for the happiness and improved health of the families who have taken cottages at Hampstead Garden Suburb.

Health Side Important.

"As women are the home makers" and home dwellers, and as the house is the shell of the home, women should have a voice in housing plans. 'The Queen Anne style in the front with the Mary Ann style at the back,' to quote Sir Edwin Lutvens, must not continue when it means all the beauty and comfort for the rich and ugliness and discomfort for the domestic worker.'

Speaking of the health side of the housing plan known throughout Great Britain as the "model village," Mrs. Barnett told how the district medical officer weighed and measured the village children and found them taller, heavier and broader than those of the same age in the city.

"That report was most gratifying to me," Mrs. Barnett commented, "because the pale faces of the little children of the Whitechapel district with which my husband and myself were so familiar, keep haunting me and urging me on to do something of this kind.

"I believe that the solution of many of our national differences and difficulties lies in a more neighborly attitude, not separation or isolation. Architects too often study how to get as many people as possible housed in a small space. It is hoped that those concerned with town planning will consider the natural intermixing of all social classes and the communion of the handlcapped with the happy."
