CIRCUIT COURT BUSY DEALING JUSTICE; WM. JOHNSON SENTENCED FOR FORGERY

The Circuit Court has been in session since the beginning of the week and has cleaned up a considerable number of cases. Most of the cases on the criminal docket did not require a jury trial, the defendants pleading guilty.

William C. Sederberg, accused of murder in the second degree, has had his case set for trial on Tuesday, March 14. On the night of January 6, Sederberg fired through a door with a 12-gauge shotgun and inflicted a gunshot wound in the arm of James Spencer. James Spencer has since died as a result of the wound. James Spencer acted as peacemaker between his son, O. D. Spencer and Sederberg, whom it is alleged have been at daggers points for some time previous.

Shortly after the shooting Sederberg, who is a son-in-law of the aged man, went before a justice of the peace and charged his brother-in-law, O. D. Spencer with having made threats against his life. Both Spencer and Sederberg were arrested. The grand jury returned a not true bill in the case of Spencer.

It is expected that this case will attract considerable interest throughout the county, and the court room is expected to be filled with spectators.

Other cases disposed of were: William Johnson, forgery, three counts; pleaded guilty to all three. Sentenced to the penitentiary for three years on every count, but the court taking into consideration the youth of the defendant, and the circumstances, suspended the sentence during good behavior, provided that Johnson reimburse the county for expenses, and report to the court every month.

Laurens Whitney, pleaded guilty to illegal cohabitation and was fined \$300. \$200 of this will be suspended during good behavior.

Wesley Raney and Grace Childers, jointly indicted for illegal cohabitation, were fined \$300. \$100 of which will be suspended during good behavior.

The case of Martingale vs. Hunt, an action for money, was disposed of Tuesday. It involved payment for the clearing of some land. Jury decided in favor of plaintiff.

The case of Weiss vs. Jackson, an action for money, had not been decided at the time of going to press. This involves the rent of a farm a few miles south of town, amounting to about \$2500.

The case of Harrison vs. Beals, is now in progress.

The court docket for the next few days consists of the case of Kings vs. Atkinson, Shipman vs. Homstock, set for Friday; Hickey vs. Shipman, set for Saturday; Bank of Bay City vs. Foley Box company set for Monday. The case of the State vs. William Sederberg set for Tuesday.

WALTER L. TOOZE FOR CONGRESS

Walter L. Tooze, Jr., of McMinnville, is a prospective candidate for nomination for congressman from the first congressional district. Recently a delegation visited him at McMinnville and urged that he get into the race. Mr. Tooze is a veteran of the world war, is active in the affairs of the American Legion, and is well known up and down the valley.

Mr. Tooze, himself, is very non-committal. "I have made no answer one way or the other," he declared. "I have been urged to run for Congress but on every occasion, I have stated that under no circumstances would I run." He stated that a number of republican leaders in various parts of the district had urged him to make the race for congress, but that as yet he had not given the matter any serious consideration.

In 1920, Mr. Tooze was a delegate to the republican national convention. He was born and raised in Marion county, and after graduating from the law school of the University of Michigan, practiced law in Polk county before entering the army. Since the war he has been located at McMinnville as a member of the law firm of Vinton & Tooze.

In 1906, his father, Walter L. Tooze, Sr., was defeated by a small plurality for the republican nomination for congressman of this district, by Hon. Willis C. Hawley, the present incumbent.

SENATOR J. D. LEE GIVES ADDRESS

Senator J. D. Lee, aspirant for the republican nomination for governor, made several speeches in the city last Tuesday. He addressed the pupils of both the grammar school and the high school during the day. He made an eloquent address at the city hall auditorium at night. For his evening address he used as his subject: "The Oregon of Today, and the Oregon of Tomorrow."

"It has been quite a number of years since I visited Tillamook," remarked the Senator to the high school pupils, "and I am greatly gratified to note the improvement and progress made in the city and surrounding country. It is the first time that I have come to the bay on a railroad."

"The hum of machinery greets the visitor," continued the Senator, "and I understand that other mills are to resume work soon. There is a vast difference here since the last time I paid this city a visit. The potentialities of Tillamook county are certainly great." Senator Lee also entertained with some of his barbaic rations.

In his evening lecture Senator Lee attacked the political practices of the state. He dwelt upon the reasons for high taxes and gave a few of his experiences while in the political life of the state. Speaking of the different commissions of the state he said: "We have in the state of Oregon as many commissions as states that have five times the population. Why do they exist and what are their duties? Some of them have no duties. And the burden of the taxpayers could be materially decreased if some of these commissions were relegated to the scrap heap."

"If we are to lessen the burden of the tax payers we must act with promptness and coolness with prudence and good judgment and good management. We want a system of economy in the management of the state."

Senator Lee was superintendent of the Oregon State Penitentiary from 1899 to 1903. He told of some of the practices of economy inaugurated there during his regime. He said when the time came for the prison to let a contract for wood, the wood dealers jumped the price of wood one dollar a cord. To get around that he called on the farmers for bids on any small amount. He received bids on amounts of from ten to a hundred cords at from \$2.75 to \$2.90 a cord. He bought all but about 70 cords of the years wood from farmers, saving the state over one dollar a cord on every cord purchased. "The last appropriation for the prison," said the Senator, "was \$296,400. This is about \$200,000 too much. There are numbers of employees that are not needed there. They are merely political hangers-on. Meat for the various state institutions should be bought on the foot. It would mean a saving of thousands of dollars annually to the state. In regards to the inspection of the meat," the Senator continued.

HALL THROWS HAT INTO RING

Senator Charles Hall, of Coos County, has announced that he will be a candidate for the republican nominee for Governor of Oregon. In the following article Senator Hall sets forth his principles and platform.

I submit my candidacy to the Republicans of Oregon for the nomination for Governor. Following are some of the principles for which I stand:

1. I have made no pre-election promises and I will make none, except those herein stated.
2. Taxes on general property must be reduced. I favor substituting not to exceed ten departments for the seventy or more existing State Commission. (Illinois System.)
3. Not only reduction of taxes, but improved marketing facilities and increased credit are essential to insure the prosperity of the farmer.
4. A more equitable adjustment of the automobile license tax with due regard to the actual value of the car. Gasoline tax for highways only.
5. As to my attitude on the labor question, I refer to my employees, and my Legislative record.
6. Completion of the State Highway System with special attention to market roads.
7. The public school is one of the fundamental factors in our system of Government. I favor compulsory attendance in the primary grades. Teach pure Americanism to all pupils, beginning at an early age. Continue to strengthen and build up this typical American Institution.
8. Strict enforcement of all laws.
9. I am against Japanese land ownership or control.

Senator Charles Hall of Marshfield, who has long been mentioned as one of the strongest prospective candidates for Governor, has announced definitely that he will enter the gubernatorial race. This announcement has been expected by his friends for some time, as strong pressure has been brought to bear upon the Coos and Curry Senator since his name was first mentioned as a prospective candidate.

He was born on a farm in Jefferson County, Pennsylvania, and came to Oregon in 1901. Shortly thereafter he began his business career as a clerk in a drug store at Clatskanie, Oregon. Eventually he acquired ownership of the drug store, sold it and bought a drug store in Hood River, where he lived until 1914. In Hood River his ability for organization asserted itself. During the eight years he spent in that town, he was one of the builders of

Two prominent citizens of Tillamook city were called to the Great Beyond in the past two days. Marsh B. Burdick, city fireman, died of acute appendicitis, and Mrs. Michael Peltz of blood poisoning. Mr. Burdick was taken ill Monday night, removed to the hospital Tuesday morning and died about 12:30 p.m. Wednesday. Mrs. Peltz has been ill for a few days and seemed on the road to recovery, but Wednesday evening things took a turn for the worse, and she died early Thursday morning.

Marsh B. Burdick was born September 7, 1881. He spent his childhood and the early part of his manhood in the state of New York. He moved to Saginaw, Mich., in 1905, and in April of 1907 was married to Henrietta Schultise. The couple moved to Tillamook in December of 1913, where they have since made their home. In 1920, he was appointed a member of the Tillamook City Fire Department and rendered faithful service in that capacity.

Funeral services will be at two o'clock next Saturday afternoon. The fire department and the lodges will cooperate on the arrangements. It is stated that an engine will be used to carry the casket to the cemetery. Services will be at the Christian church.

He is survived by a wife, mother, four small children, four brothers and three sisters. Those surviving him are Mrs. Henrietta Burdick; his mother Mrs. Chas. Page, of Hornell, N. Y., two sons, Norman M. and Clarence R.; two daughters, Marguerite L. and Rosetta V.; four brothers, Charles, of Corvallis, N. Y., Menzo, of Wellsville, N. Y., Norman, of Portland, and Herbert, of Rochester, N. Y.; three sisters, Mrs. Cora Brun, of Plainsville, N. Y., Mrs. Jennie Carr, of Andova, N. Y. and Mrs. Ione Furness, of Horning, N. Y. He leaves a number of relatives, and a host of friends in Tillamook.

He is a member of the Marathon Lodge, No. 89, Knights of Pythias, and Udu-Uhl-Atef Temple, No. 117, Knights of Khorasan.

Mrs. Caroline Peltz was born at West Phalen, Germany, forty-five years ago. She came to this country with her parents thirty-five years ago, and settled at Moberly, Mo. In 1896, she came to Tillamook, was married to Michael Peltz, April 19, 1897. Five children were born to this union.

Her husband preceded her in death, having died August 23, 1904. She is survived by five children, Mary, Nic, Rose, Clara and Helen. She leaves a host of friends in Tillamook. Funeral will be from the Sacred Heart church, at two o'clock Sunday afternoon.
