

SCHOOL EXHIBIT AT COUNTY FAIR

One of the most interesting features of any county fair is the school exhibit and this year was no exception. The exhibits, which are taken from the daily work of the children serve to demonstrate not only the ability of the children, but of the teacher as well.

The folders and other art work shown displayed a great deal of talent among the children, and originality of ideas. The teachers are given a great deal of credit for their work in selecting and preserving these specimens for displays, which always make an impression on the children whose work is shown and serve as an incentive to better work.

OREGON BENEFITS BY NATIONAL FOREST RECEIPTS

Oregon is second in the list of states benefiting financially from the sale of national forest receipts, according to information just received at the office of the district forester, Portland, Oregon.

Under act of congress, one fourth of all money received by the forest service from timber sales, summer domestic leases, grazing permits and other miscellaneous uses is returned directly to the counties in which national forests are located to be spent by them for roads and schools.

These so-called 10 per cent. and 25 per cent. funds are in lieu of taxes on the lands under national forest management. Unlike the taxes accruing from many other timberlands, which produce one crop and are then standing idle and useless, the national forest lands are producing greater contributions each year, and will continue to do so, as they are managed on a basis of continuous production, according to forest officers.

This is illustrated by the increase in Oregon where the returns to the state and counties under the 25 per cent. fund have increased from \$7,383.96 the first year, in 1906, to \$176,943.77 in fiscal year 1924. In 1906 the 1907 road and school return was only 10 per cent. of the receipts, being raised to 25 per cent. in fiscal year 1908. Under the present 10 per cent. fund, which began in fiscal year 1912 the returns have increased from \$1,023.81 in 1912 to \$70,777.51 in fiscal year 1924.

During the period these two acts have been in operation Oregon's receipts from the 25 per cent. fund have been \$1,446,438.18 and under the 10 per cent. fund, \$513,678.51.

YOUR EYES

Modern civilization has greatly increased the fatigue of the eyes. The reading of the printed page throws an enormous strain on the eyes by requiring it to make many

more movements than are called for in visualizing large objects. The eye is one of the organs most commonly trained in modern life. In its modern use, the eye is constantly focusing at short distances. Unfortunately many of us, in fact more than sixty per cent, have physical defects of vision. By this is meant that the eye is defective to an extent that causes the vision to be less than normal, or that good vision is obtained through an exertion which causes strain. No physical defect contributes more directly to fatigue and in efficiency than eye strain or is more responsible for waste of vitality, effort, time and material. Headaches, nausea, and dizziness are especially frequent results of eye strain. Print blurring, restricted distant vision, occasional double vision, muscular twitchings, digestive disturbances and a variety of other manifestations may be due to eye strain.

Your eyes require intelligent care. If you have headaches or if in reading, the book is held nearer than twelve inches, you should have your eyes examined by an eye specialist. Lack of proper care causes a variety of eye defects. Avoid fine work. Such work is especially bad for children and should not be continuous. Rest your eyes frequently from study and close work. The muscles are relaxed by directing the eyes on distant objects.

Reading on moving trains, looking for a long time at moving pictures, reading in a recumbent position, reading in a dim light, facing a glaring light, should be avoided as harmful to the eyes. For the purpose of conserving your vision the direction, source, power and color of artificial illumination are important. The light should be steady. It should be of sufficient intensity to illumine without glare and no shadows should be produced on the reading or work surface.

Be sure your vision is corrected by properly fitted glasses. Have this done by an eye specialist. Do not try to fit cheap glasses to your eyes. Eye strain from badly fitting glasses may in time seriously affect your eyesight or health. Your eyes should be examined frequently by an eye specialist. Not only should he examine the eye optical defects but he should interpret the eye conditions in terms of general disease. The eye responds quickly to lowered state of bodily efficiency. Good health means to a large extent right living, and the eyes will share in general effects.
