On Saturday June 15th, at one o'clock, there will be a meeting of the court house in the interest of the Tillamook County Fair Association. The stock holders and those who are interested and will take stock are requested to be present and take part in the business that is to be transacted. A board of directors will have to be elected and other important business looked after. A good crowd should be in attendance and give the association a good boost on the 15th, as that date is indeed a critical time and we ought to put lots of enthusiasm into the matter and give those who have the organization in charge plenty of encouragement. A good live fair association means a great deal to Tillamook County.

The booklet on Tillamook County which has been under discussion for some time and which has been published under the auspices of the County Court is now ready for distribution. While the booklet may not in every way suit everyone, it will in a general manner give the outsider a pretty good idea of what Tillamook County is like. There is one good feature about the book and that is the fact that its story is in no wise overdrawn. The information contained therein can be relied upon in every particular. In fact, it would take a book many times larger to tell the true story of Tillamook County's greatness. A large supply of the booklets can be found at the Tillamook Commercial Club rooms, and those who may desire some of them to send to their friends can have them by calling for them at the club rooms.

Monday, the 16th day of June, is Annual School Meeting Day, and Supt. of Public Instruction L. R. Alderman, asks us to lay special stress on this matter and call upon the people to take an interest in the affairs of the day. We believe that this is a fine idea. Heretofore but few of our people have taken any interest in the affairs of School Meeting Day and school matters have been allowed to drift along without much attention until an occasion is found for criticism and then there is sometimes quite a ruction for a while. The people should take an interest in the school on School Meeting Day, turn out and discuss school matters with one another, learn the needs of the school and help get the business affairs of the year started right. Let everybody turn out to the school meeting next Monday. School matters should not be neglected.

Tillamook cheese laid down at dock is now bringing 12-14c per pound. This is the highest price that has ever been paid for Tillamook cheese at this time of the year, and is a point and a quarter more than was paid at this time last year. We know that this glad news must bring sadness to the heart of Editor Baker of the Headlight, the champion booster for Tillamook County; the man who always looks on the bright side of things when the standpatters are in power and there is a good postoffice job in sight, but who is in the dumps and can see nothing but rutation ahead of us when things are otherwise. Eliminating the nonsense, we will admit that our democratic administration is not directly responsible for the present high price of cheese. However, we do contend that the present price of cheese is a very good indication that there is a sound and stable condition in the business affairs of the country in general and the Pacific Coast country in particular, which means, if it means anything, that the honest business men of the country have confidence in the present administration, and the dishonest fellows have decided to be good because President Wilson has told them what he would do to them if they would not do as they ought to.
