Congress Favors Presidential Primary A careful poll indicates a clear mafority of the senate and house favors presidential preference primaries.

Only a small minority is outspoken in its opposition to nation-wide primaries, with the candidates formulating the platform upon which they will appeal to the people for election. President Wilson has adopted the plan.

The sole obstacle in the way of prompt action by congress on this matter is the doctrine of states' rights. It is the excuse which those really opposed to the primary principle will offer.
