gress shall be a member of federal reerve board or an officer or a director of a federal reserve bank. No director of Class B shall be an

officer, director or employee of any No director of Class C shall be an officer, director, employee or stock-

holder of any bank. Class C directors shall be appointed

the federal reserve board. They shall have been for at least two years residents of the district for which they are appointed, one of whom shall be designated by said board as chairman of the board of directors of the federal reserve bank and as "federal reserve agent." He shall be a person of tested banking experience. and in addition to his duties as chairman of the board of directors of the federal reserve bank he shall be required to maintain under regulations to be established by the federal reserve board a local office of said board on the premises of the federal reserve

Sec. 5. The capital stock of each federal reserve bank shall be divided into shares of \$100 each.

#### Division of Earnings.

Sec. 7. After all necessary expenses of a federal reserve bank have been paid or provided for, the stockholders shall be entitled to receive su the paid in capital stock, which dividend shall be cumulative. After the aforesaid dividend claims have been fully met all not earnings shall be paid to the United States as a franchise tax, except that one-half of such net cornings shall be paid into a surplus fund until it shall amount to 40 per centum of the paid in capital stock of euch bank

The not earnings derived by the Unit ed States from federal reserve banks shall, in the discretion of the secretary. be used to supplement the gold reserve held against outstanding United States notes, or shall be applied to the reduction of the outstanding bonded in debtedness of the United States. Reserve banks shall not be taxed except upon real estate.

Section 8 amends the existing bank ing lives, so that stockholders owning 51 per cent of the stock of banks other their national banks can convert their organizations into national banks.

Se then 9 describes how state banks may become members of reserve banks.

### FEDERAL RESERVE BOARD.

Seven Membars, Five of Whom Are to Get \$12,000 a Year Each.

Sec. 10. A federal reserve board is hereby created, which shall consist of seven members, including the secre tary of the treasury and the comptrolor of the currency, who shall be members ex officio, and five members apcointed by the president of the United States, by and with the advice and consent of the senate. In selecting the five appointive members of the federal reserve board not more than one of whom shall be selected from any one tederal reserve district, the president shall have due regard to a fair representation of the different geographical divisions of the country. The five members of the federal reserve board appointed by the president and confirmed aforesaid shall devote their entire time to the business of the federal reserve board and shall each receive an annual salary of \$12,000, together with actual necessary traveling expenses. and the comptroller of the currency. as ex officio member of the federal reserve board, shall in addition to the calary now paid him as comptroller of the currency, receive the sum of \$7,000 mutally for his services as a member of said board. The members of said board, the secretary of the treasury, the assistant secretary of the treasury and the comptroller of the currency shall be incligible during the time they are in office and for two years thereaft er to hold any office, position or employment in any member bank. Of the five members thus appointed by the president at teast two shall be persons experienced in banking or finance. One shall be designated by the president to serve for two, one for four, one for six, one for eight, one for ten, and thereafter each member so appointed shall serve for a term of ten years unless somer removed for cause by the president. Of the five persons thus appointed one shall be designated by the president as governor and one as vice governor of the federal reserve board. The governor of the federal reserve board, subject to its supervision, shall be the acting ex-

ecutive officer. The federal reserve board shall have power to levy semiannually upon the federal reserve banks in proportion to their capital stock and surplus an assessment sufficient to pay its estimated expenses and salaries of its members and employees for the half year succeeding the levying of such assessment. together with any deficit carried forward from the preceding half year.

The first meeting of the federal re-serve board shall be held in Washington, District of Columbia, as soon as may be after the passage of this act at a date to be fixed by the reserve bank organization committee. The secretary of the treasury shall be ex officio chairman of the federal reserve board. No member of the federal reserve board shall be an officer or director of any bank, banking institution, trust company or federal reserve bank nor hold stock in any bank, banking institution or trust company, and before entering upon his duties as a member of the federal reserve board he shall certify under oath to the secretary of the treasury that he has complied with

Cis requirement. Whenever a vacasey shall occur other than by expiration of term among the six members of the federal reserve board appointed by the president, as above provided, a success sor shall be appointed by the president. with the advice and consent of the senne, to fill such vacancy.

Tre president shall have power to fill all vacancies that may happen on the federal reserve board during the recess of the senate by granting commissions which shall expire thirty days after the next session of the senate

### RESERVE BOARD POWERS.

iter, 11. The federal reserve board shall be authorized and empowered: (a) To examine at its discretion the accounts, books and affairs of each federal reserve bank and of each member bank and to require such statements and reports as it may deem necessary. The said board shall publish once each week a statement showing the condition of each federal reserve bank and a consolidated statement for all federal reserve banks. Such statements shall show in detail the assets and liabilities of the federal reserve banks, single and combined, and shall furnish full information regarding the character of the money held as reserve and the amount, nature and maturities of the paper and other investments owned or held by federal reserve banks.

(b) To permit or on the affirmative vote of at least five members of the reserve board to require federal reserve banks to rediscount the discounted paper of other federal reserve banks at rates of interest to be fixed by the federal feserve board.

(c) To suspend for a period not exceeding thirty days, and from time to time to renew such suspension for periods not exceeding fifteen days, any reserve requirement specified in this act. Provided, that it shall establish a graduated tax upon the amounts by which the reserve requirements of this not muy be permitted to fall below the level bereinafter specified; and provided, further, that when the gold reserve held against federal reserve notes falls below 40 per centum, the federal reserve board shall establish a graduated tax of nor more than 1 per entum upon such deficiency until the reserves fall to 32% per centum, and when said reserve falls below 32% per centum, a tax at the rate increasngly of not less than 11; per centum upon each 21/2 per centum or fraction thereof that such reserve falls below 32% per centum. The tax shall be paid by the reserve bank, but the reserve bank shall add an amount equal to said tax to the rates of interest and discount fixed by the federal reserve

(d) To supervise and regulate through the bureau under the charge of the comptroller of the currency the issue and retirement of federal reserve notes, and to prescribe rules and reguiations under which such notes may be delivered by the comptroller to the federal reserve agents applying there-

(e) To add to the number of cities classified as reserve and central reserve cities under existing law in which national banking associations ire subject to the reserve requirements set forth in section 20 of this et, or to reclassify existing reserve and central reserve cities or to terminate their designation as such.

(b) To require bonds of federal reserve agents, to make regulations for the safeguarding of all collateral. bonds, federal reserve notes, money or property of any kind deposited in the hands of such agents, and said board shall perform the duties, functions or services specified in this act and to make all rules and regulations necessary to enable said board effectively to perform the same

(j) To exercise general supervision over said federal reserve banks

(k) To grant by special permit to national banks applying therefor, when not in contravention of state or local law, the right to act as trustee, executor, administrator or registrar of stocks and bonds under such rules and regulations as the said board may pre-(h To employ such attorneys, ex-

perts, assistants, clerks or other employees as may be deemed necessary to properly conduct the business of the board. All salaries and fees shall be fixed in advance by said board and shall be paid in the same manner as the salaries of the members of said board. All such attorneys, experts. assistants, clerks and other employees shall be appointed without regard to the provisions of the act of Jan. 16. 1883 (volume 22. United States statutes at large, page 403), and amend-ments thereto or any rule or regulation made in pursuance thereof.

Section 12 creates a federal advisory council, consisting of one member from each federal reserve district. which is empowered to confer with the federal reserve board and make representations regarding the business of the board.
