## Good Roads Boosters Meet.

Sam Hill, Good Roads Man, May Be Here in June. Much Interest Taken in Move.

The Tillamook County Good Roads Booster Club met at the Commercial Club rooms on Monday evening and discussed matters relative to the work which they have in hand. Those present were J. H. Dunstan, President; H. T. Botts, Secretary; Out of town members were Mr. Chapin of Bay-ocan; W. S. Cone and J. O. Bogorth of Bay City, and Frank Rowe of Nehalem.

Among some of the things discussed was the attitude of the timbermen towards bonding the county. Mr. Cone stated that while on a late trip to Portland he had talked to representatives of several of the big timber owners, and that they all seemed to be in favor of bonding. Their argument being that if we bonded the county and let the road work in large contracts that we would save at least from 25 to 30 per cent in the construction of our roads and then we would have the kind that would serve the people and would last.

Sam Hill, the good roads man, has signified his willingness to visit our county and give us an address on the subject of better roads. Upon Mr. Chapin was placed the responsibility of arranging a date suitable to Mr. Hill. It is thought that a date sometime during the fore part of June will be set. Mr. Hill illustrates his lecture with pictures thrown on a screen and it is possible one of our theatres may be secured for the meeting.

Following is an outline of the purposes of the club as written by Mr. Bogorth and endorsed by the club:

The Tillamook County Good Roads Boosters Club organized to promote the cause of good roads throughout the county and to gather data and information on the building and maintenance of roads, the best roads to build, considering our soils, climate, etc., as well as how best to provide the funds for building them, having always in view the burden of taxpaying as well as the needs of the traveling public. The club is seeking expert advice.

## COMMERCIAL CLUB ELECTS OFFICERS.

On Monday evening, the Commercial Club of this city elected the following officers for the ensuing year: A. H. Gaylord, Pres.; Cal. Worrall, Secy.; Will Spalding, Treas.; C. W. Talmage and Geo. Henderson, Directors.

After the election of officers Mr. Manning, one of the Democratic candidates for the office of governor, was presented. Mr. Manning gave a very entertaining 10 minute talk, explaining to some extent his scheme of getting the people from the cities to the land. One statement which he made, which will give us some idea as to the reason for the high cost of living especially in Oregon, was to the effect that one-third of the people in Oregon live in Portland and five-sixths of the people in Oregon live in incorporated cities, leaving only one-sixth of all our people to produce food products for the other five-sixths. Mr. Manning returned to Portland this morning.

It is expected that soon experienced road builders, including Mr. Samuel Hill, a road builder of international reputation, will deliver addresses to the people of the county on the subject of roads.

Correspondence has been begun with other counties that are already building permanent roads, to ascertain their plans, and also with the Division of Roads, in the United States Department of Agriculture at Washington, to secure as far as we can, the benefit of the advice and counsel of professional road builders.

The club realizes that the building of permanent roads in Oregon is a new thing. That better methods are coming into vogue in other parts of the country than in ours. That our gravel and light macadam roads, while costing a lot of money to build and rebuild will not stand up under the wear of heavy traffic, especially of vehicles with narrow tires. That some of the essentials of good road building are not being put in practice by our people.

As soon as enough data is at hand the club will publish its conclusions and reasons as to that the people may get the benefit and be better prepared for intelligent action when the time for action comes.

The club is not a "knockers" club in any sense of the term. It is not organized to criticize any official or officials. It believes in good permanent roads for Tillamook County, and as the building of these roads will involve the spending of large sums of money that will have to be raised by taxation, the interests of the taxpayers as well as of the travelling public will be best conserved by building the best kind of roads for the least expenditure of money.

And it believes that a road once built should be taken care of. Now, the best method of building and caring for roads is what this club is trying to find out. And in this search it cordially invites the cooperation of the people of the county.

It requests that good roads clubs be organized in every neighborhood in the county, where road questions will be discussed and road building and care investigated. In this way the interest will be widespread and great good will be done.

The campaign for good roads is largely a campaign of education, and one in which every citizen should take an active interest.

The era of good roads is dawning in Oregon, and Tillamook County will be saved much "grief" and large sums of money if the lesson of road building and upkeep is well learned before spending day comes.

## CIRCUIT COURT NEWS

Judge Holmes convened Court on Monday. The first case to come up for consideration was the case State vs. Currey. Defendant was indicted on the charge of securing money under false pretenses. However as the district attorney failed to have evidence and was not ready for trial and did not show due diligence, the case was dismissed.

In the case of A. Ramsey and Tillamook County Bank vs. Milwaukee Mechanics Insurance Co., a directed verdict against defendant was given in favor of the Tillamook County Bank for \$1500 and interest under mortgage clause in the policy, representing a loan by bank to Ramsey of \$1500. Court directed verdict in favor of defendant against A. Ramsey for costs. Under the proof the policy was rendered void by act of Ramsey procuring subsequent insurance without consent of the defendant insured on policy or written into it, but such act did not render it void as to the Tillamook County Bank under the statutes of Oregon and the evidence adduced and the terms of the policy.

In the case of A. L. Steiner vs. O. A. Jackson, action for damages for breach of contract of sale of Holstein dairy cows, verdict was returned in favor of plaintiff Steiner for \$458 and costs, order of sale of attached property.

Case of Hefti vs. V. Jacob was dismissed by agreement of parties without cost.

All Jury cases have been disposed of for this term of court and Jurymen with the exception of Dr. Monk and Henry Rogers were dismissed.

Some equity cases which are on the docket will be taken up in June. In the meantime Judge Holmes will preside at an adjourned term of court at McMinnville, beginning about May 6th.

**THE WAR NEWS**  
Nothing startling has been heard in the days to come to the situation, although transpiring events are interesting.
