W. A. Williams is having some improvements done to his store building formerly occupied by the Peoples' store. The building will be lowered so that the door will be even with the walk and a new foundation will be placed under it. A new plate glass front will also be built in. G. L. Hamlin will have charge of the lowering of the building and W. J. Lisberg has charge of the carpenter work.

Louis Hutchinson and Jack Lowe were arrested on Saturday night by Marshal Myers on charge of stealing an overcoat from Herman Schiappi. They were put in jail, but were released on Monday as there was no city ordinance covering their case. District Attorney Gayne would not take the matter up in behalf of the state as he did not consider the evidence sufficient. The overcoat was taken from the Dawson barn.

### BRIEF NEWS OF OREGON

The number of graduates from the Oregon Normal school for the present term will far exceed 100.

Logging operations in eastern Oregon are greatly hampered this winter by lack of snow in the mountains.

Counties of Oregon paid a total of \$88,408.99 interest on warrants during the nine months ending September 29.

The Siuslaw port commissioners during the week authorized the sale of \$100,000 bonds for the improvement of the Siuslaw harbor.

First company, coast artillery, of Ashland, has asked that Governor Withycombe reappoint W. E. Finzer as adjutant general of the Oregon National Guard.

Although the past season was the most dangerous one on account of dryness, for many years, the total loss of timber by fire in Coos county was only 7,999,999 feet.

Ed Bostwick of Floras Creek district was brought into Coquille by Game Warden Thomas, following the discovery of evidence that indicated that he had killed 40 deer.

An aggregate of 92.72 miles of railroad was constructed in Oregon in the year 1914, according to records compiled by the Railway Age-Gazette. The state of Washington built 296.34 miles and Idaho 150.11 miles.

Records of the city engineer and building inspector show that the city of Marshfield expended \$337,090 in the construction of new buildings, repairing others, and for paving and other street improvements during the year.

No more liquor of any kind under any circumstances will be sold in the drug stores in Coos county. This was decided upon at a meeting of the Coos County Pharmaceutical association when resolutions to this effect were passed.

State Dairy and Food Commissioner J. D. Mickle has prepared drafts of two bills for presentation to the coming session of the legislature, looking toward the correction of existing evils in the present sanitary and cold storage laws.

The Dulles city park association has sold its fairgrounds, just west of the city, to Wasco for \$12,000. The property will be used by the county for a poor farm, but will be maintained in such a way that the grounds will be available every fall for the Wasco county fair.

The Oregon Irrigation congress closed its fourth and largest annual session at Portland. The following officers were elected: President, Ana B. Thomson, Echo; secretary, Fred N. Wallace, Ladlow; vice presidents, J. W. Brewer, Portland; John Rigby, Vale, and A. M. Crawford, Salem.

County Judge Maloney, who had held office two years longer, by a bare vote with a ruling of the supreme court, resigned in favor of Charles W. Marsh, who defeated T. P. Gilliland for the office in the November election, and who was appointed to the position by Governor Went.

The legislative committee of the state editorial association met in Portland and decided to recommend to the association that it approve a law requiring a uniform rate on all publications required by law, and that the unit of charge be the line of type, rather than the linear measurement.

Indeed purchasers of lands within the Benson and Hyde school sections will be given confirmatory deeds to the property on payment to the state of \$2.50 an acre if the provisions of a resolution adopted by the state board become effective. The interior department will be asked to approve the plan.

Representative Hawley, since his return to Washington, has been laboring with the forest service trying to expedite action on the classification of lands in the various forest reserves in his district, and especially the Siuslaw reserve, from which he hopes to have eliminated a considerable area in Lincoln county.

That the state may be saved \$100,000 by doing away with the census this year seems probable. As a result of the suggestion of Secretary of State Olcott to abolish the census, which has been taken every 10 years since 1865, the secretary has received assurances that a bill will be introduced making the new law effective May 19 of this year.

The state highway commission has placed a petition, presented to it by the citizens of Columbia county, asking for the removal of State Highway Engineer Bowly, on file without discussion. The signers of the petition charged the state highway engineer with extravagance and incompetency in the construction of roads in Columbia county.

Pronouncing the present law providing that the fiscal year shall commence on the first day of January of each year, and that it shall close on the day preceding the first day of the same month unsatisfactory and unbusinesslike, Secretary of State Olcott in his biennial report to the legislature recommends that it be amended to read that the fiscal year shall commence on the first day of July of each year, and close on the thirtieth day of June.

**Lands Cheaply Logged Off**

Feeney-Bremer Co., Put Economical Land Clearing Machine on Market

The Feeney-Bremer Co. has just completed a very economical device for clearing land in the shape of a gasoline donkey engine, equipped with a 10 h. p. heavy duty engine. The total weight of the machinery is 5,200 lbs. mounted on runners and can be pulled anywhere on a straight line by its own power.

The donkey part consists of a double drum, double friction, equipped with breaks. It has 400 feet of 1/2 in. cable and 800 feet of 3/4 inch cable. As a demonstration it recently pulled with ease a 20 foot log 3 feet in diameter over rough ground. Anyone wishing a demonstration of the workings of the machine can witness the same by calling at the Feeney-Bremer Co. Works.

The price for the above equipment ranges from \$700 for 10 h. p. up, larger sizes costing accordingly.

The engine consumes distillate, consuming 6 gallons in 10 hours, cost 10c. a gallon.

The engine used is detachable and can be used for other things.

Feeney-Bremer Co. are offering a fine proposition for two or more farmers who wish to go in together on a device that will clear their land cheaply.
