

NOTICE OF DELINQUENT TAXES OF REAL PROPERTY IN TILLAMOOK COUNTY OREGON, FOR THE YEAR 1913.

The taxes on the following advertising of real property are delinquent, and are subject to a penalty of ten per cent and interest at the rate of twelve per cent per annum until the same taxes shall have been paid.

Notice is hereby given that six months after the expiration of the period for the payment of the taxes, the same shall be sold to satisfy the same. Certificates of delinquency against the said property for delinquent taxes. The said certificates of delinquency will bear interest at the rate of twelve per cent per annum until the certificates are redeemed.

After the expiration of three years from the first date of delinquency of any tax included in a Certificate of Delinquency the holder of such Certificate may cause a summons to be served on the owner of the property described in the Certificate, notifying the owner that he will apply to the Circuit Court of the county in which such property is situated for a decree foreclosing the lien against the property described in such Certificate.
