## OREGON NEWS NOTES OF GENERAL INTEREST

Principal Events of the Week Briefly Sketched for Information of Our Readers.

The Harrisburg sawmill will resume operations within a few days.

The bankers of Linn county met at Albany and formed a county bankers' association.

The 33d annual convention of the Clackamas County Sunday School association was held in Oregon City.

Lincoln county will celebrate the 30th anniversary of its becoming a division of the state on March 9.

The ninth death from sleeping sickness since January 1, 1923, was reported to the city health department of Portland.

William Doby, former county judge of Baker county, has accepted Governor Pierce's appointment as state highway commissioner.

Postmasters nominated by President Harding include Robert N. Forbet, Albany; Claude E. Ingalls, Corvallis; and Darwin R. Yoran, Eugene.

The Charles K. Spaulding Logging company of Salem has announced that it has raised the pay of its common laborers from \$3 to \$3.40 a day.

The city service commission has been requested by the postoffice department to hold an examination for the selection of a postmaster at Marshfield.

President W. J. Kerr of Oregon Agricultural college has gone to Baltimore, Md., to attend the session of the Grand Council of De Molay, a Masonic order for boys. He will return in two weeks.

Thirty pairs of Hungarian partridges which were received from the state game commission, were released in various parts of the Grand Ronde valley by the Wing, Fin and Fleetfoot club of La Grande.

The executive committee of the Willamette Valley Chautauqua association has voted to provide independent attractions for the 13 days' Chautauqua at Gladstone. July 10 to 23, inclusive, are the dates fixed for this year.

Albany retail merchants representing 20 firms have organized with Ben Bartscher chairman and W. A. Eastburn secretary for protection and co-operation. The association will act as an auxiliary to the chamber of commerce.

Nineteen head of full-blooded Holsteins, the property of George A. McCarter of Harrisburg, were shipped to Portland, all marked with tuberculosis ear tags. They will be slaughtered in the presence of a government inspector.

Eugene made a good record in building last month, according to the report of W. H. Alexander, city building inspector. Twenty-seven permits were issued during the month and the estimated value of construction is \$184,395.

Mayor Baker of Portland has issued a proclamation designating the week April 9-14 as "Home Beautiful" week. All citizens of Portland are urged by the mayor to co-operate in the plans made to promote home ownership and home improvement.

Governor Pierce received a petition signed by several hundred citizens of Umatilla county requesting that a parole be granted to Elvin Nelson, who was received at the penitentiary in Salem last month to serve a term of two years for larceny.

A survey of the proposed \$300,000 high-line from Pasco, through Umatilla to Pendleton, has been begun by engineers of the Pacific Power & Light company and actual construction will start early this summer. The work will be completed before next winter.

Without waiting the outcome of negotiations of the Building Trades Council with the Building Construction Employers' association for a 10 per cent increase in wages, members of the painters' union of Portland went on strike, refusing to work for less than \$8 a day.

There was one fatality in Oregon due to an industrial accident in the week ending March 1, according to a report issued by the state industrial accident commission. The victim was Walter Scott, choker setter, of Silverton. A total of 563 accidents were reported.

Under a ruling announced by the state superintendent of schools, the teachers' training course offered through the last year of the standard high school hereafter will be considered equivalent to the 24 weeks' course provided at the state normal school at Monmouth.

Adjutant-General White has returned to Salem from Tillamook, where he inspected the site for the proposed new armory which is to be erected there during the present year. The recent legislature made an appropriation of \$20,000 for this structure. A similar amount will be appropriated by Tillamook county.

Herbert West, 15-year-old Portland youth, who was committed to the state training school for boys, set free three months ago after he had confessed to participating in a series of robberies, made his second escape from the institution last week.

Roley Swyter, who was arrested in a raid on his farm home near Albany when 150 gallons of wine were seized, was sentenced to serve six months in the Linn county jail and fined \$500 when he pleaded guilty to having intoxicated liquor in his possession.

Street improvements comprising grading, surfacing with crushed rock, and installation of curbs, were recommended by the streets committee of the Bend city council, the entire improvement involving an estimated expenditure of \$125,000 for the coming year.

The state highway commission will furnish Astoria with all the trucks, wheelbarrows, picks and shovels it will require in cleaning the streets and in reconstruction work in the burned district free of charge, the only expense to the city being the cost of operation.

Contract for the erection of the Portland unit of the Shriners' hospital for crippled children was awarded to Stebbins Bros., general contractors of Portland, for approximately \$175,000. Sub-contracts also were awarded. The total cost of the hospital will be almost \$260,000.

Berry growers from all parts of Coos county organized at a meeting held in Myrtle Point, at which about 15 were present. They effected the organization for the purpose of securing better marketing facilities and generally improving conditions. Much larger areas of berries are to be put out this year.

H. J. Overturf, member of the lower house of the state legislature from the 21st district and a former member of state bonus appraisers, appeared at the United States marshal's office in Portland and accepted service on a warrant charging him with use of the mails to promote a fraud against the Oregon bonus law. Mr. Overturf immediately gave bond in the sum of \$2500.

The Lane county court is planning to sell a block of \$400,000 of its highway bonds at once. This will take care of all bond projects planned for this year. The projects to be worked this year are three sections of the old territorial road, a section of the high pass road to Lake creek valley, the Glenada-Ada road, the surfacing of the North Ford road and the Coburg-Linn county line road.

The Pacific States Lumber company, known better as the Coos Bay lumber company, will complete extensive enlargements and improvements of its great plant at Marshfield about June 1 and will then operate on a production basis of approximately 800,000 feet in eight hours, according to announcement by William Denman of San Francisco, chairman of the board of directors and executive committee of the concern.

The Umpqua valley broccoli crop will be the best from the standpoint of quality and quantity that has ever been produced there, unless future weather results in damage. With the largest acreage in the history of the industry in the valley, the weather has been very favorable for a good growth and all indications point to an unusually fine crop. Heads of some of the early varieties are beginning to come in already, but the bulk of the crop will not be harvested until the next week.

An investigation to determine why the state bonus commission has refused to grant loans up to 75 per cent of the value of the property offered for security will be made by Umpqua post of the American Legion. It has been reported that several ex-convicts in Douglas county have endeavored to get loans and have offered property of considerable value as security, the security in every case being sufficient to gain a much larger loan than was allowed by the bonus commission.

Central Oregon sheepmen are optimistic, for unless unusual conditions should develop the winter season will have been almost ideal. This winter feed has been plentiful. In fact, many ranchers will carry over large quantities of hay for use next season. Winter range has been available part of the time and with plentiful supplies of hay in reserve stock is coming through the winter in excellent shape. This in turn should mean more and a better grade of wool, which may be expected to have its effect on the prices of the 1923 clip.

As a direct result of its recent victory in the extra income tax controversy the Union Fishermen's Co-operative Packing company of Astoria will distribute approximately \$75,000 among its 300 stockholders. Some years ago the company created what was known as the shareholders' redeeming fund and it amounts to about \$300,000. For the years 1917 and 1918 the department demanded an extra income tax on this fund on the ground that the money was "borrowed capital," belonging to the stockholders and not to the company. The packing company contested this and won.

A Canadian war veterans' club was organized at Bend with 19 members.

A round-up of bootleggers staged at Albany resulted in four arrests and fines totaling \$820 with two 30-day jail sentences.

The Lane county grand jury has recommended construction of a new county jail or enlargement and alteration of the present one.

Will Moore of Portland was appointed state insurance commissioner to succeed A. C. Barber. Mr. Moore assumed his new duties March 1.

The Douglas county corn and potato show was held in Roseburg last week. Exhibits of potatoes and corn from all parts of the county were on display.

H. J. Roosa, a government trapper in the Powell Butte section of Crook county since last fall, reports that he has caught 123 coyotes and 19 bobcats.

The second biggest Mystic Shrine activity in the history of Oregon is to be staged in Salem May 5. Between 4000 and 5000 Shriners will be in attendance.

Jack Fulton, brother of Fred Fulton, heavyweight boxer, has escaped from the Lane county jail where he was serving a six months' sentence for bootlegging.

According to the supervisor of the Whitman national forest reserve, \$31,000 has been allotted for the next year for construction and upkeep of roads in the reserve.

The old Vale flour mill has been taken over by experienced milling men and will be put into shape to start grinding wheat as soon as this year's crop is harvested.

Twenty-one hundred registered voters in Linn county have failed to cast ballots during the last two years, a check of the three state elections held during that time shows.

The market road fund in Douglas county will be used to match the special road tax voted by the various districts, according to a policy inaugurated by the county court.

The biggest moonshining plant ever taken in central Oregon was unearthed when Sheriff Roberts of Deschutes county seized a 500-gallon still in a cave five miles south of Bend.

During January Astoria moved up from 43d to 40th place among all the cities of the United States in the amount of postal deposits, the gain being the third largest in the country.

Collection of 1923 taxes in Multnomah county has begun so satisfactorily that a force of 12 night workers has been placed on duty in the tax division of Sheriff Huriburt's office.

The third unit of the Shevlin-Hixon company's plant at Bend started cutting March 1. The new unit contains a band saw and gang, the first to be used in pine milling east of the Cascades.

To protect the immense bodies of pine timber in the arid Fox Butte region of the Deschutes national forest, a three-ton fire truck will be placed at the Camin lake ranger station next summer.

The Daughters of the American Revolution Friday dedicated a huge rock marking the site of the pioneer trail by which the first settlers entered Salem. The boulder is located in Wilson park on State street.

Fifty Umatilla county sportsmen used 10,000 shotgun shells to kill 8000 rabbits and the record kill was made by one team of 20 men that shot 670 rabbits in 15 minutes in the big annual Pendleton rabbit shoot held last week.

Nearly twice the normal proportion of pupils failed in their scholastic work in Bend last term, due to overcrowding incident to the rapid growth of Bend's population, said City Superintendent Ager. More than 10 per cent failed.

At the present time there is 11,000 acre feet of water in the Ochoco dam. With several feet of snow in the mountains east and west of Prineville, there will be plenty of water for irrigation. Total capacity of the Ochoco dam is 47,000 acre feet.
