### **Highway Funds** Are Allotted For Vernonia

TWO ROADS TO SHARE IN ALLOCATION

Pavement and Resurfacing Jobs Both to Be Let

\$25.000 for resurfacing 6.5 miles of the Buxton-Treharne section of the Beaver Creek highway and \$18,000 for resurfacing 2 miles of the Vernonia-Pittsburg section of the Nehalem highway were allocated by the state highway commission Wednesday. This will asure improvement of the Beaver Creek route so that it will be in good shape for winter travel, and the construction of an Helens, next Sunday. oil pavement from Al Parker's to Pittsburg. The entire amount of money spent in the Vernonia section, \$43,000, is considerably greater than, was expected when discussion arose here as to the disposition of federal funds to be recommended.

Another decision of interest locally was the allocation of \$175,000 for improvement of the Wolf Creek highway between Necanicum and Elsie. This will afford a connection between the Nehalem highway and the Oregon Coast highway by way of Jewell, and will make possible the use of this route from Portland through Forest Grove and Vernonia without waiting for the construction of the difficult section between Sunset Camp and Elsie.

## **Dunne Favors** Work Program On Large Scale

NOMINEE VISITS HERE FOR SHORT TIME

Chats with Friends on Issues Now Confranting State

A program for putting men to work extensive enough to take care of the majority of idle men in the state through the development of small industries was advocated yesterday by Joe E. Dunne, republican nominee for governor, in conversation in Vernonia yesterday afternoon. He favors the issuance of scrip financed by state deposits and the stamp redemption plan, for loaning to plants in need of funds.

Another item he stressed is the stabilization of prices for agriculture. The department of agriculture is now a department of inspection, he said. It should be a department with a program that will help the farmer develop markets.

He also declared that he would arge the legislature to enact a fair practices act for retailers so that the retailers can make a living. "Some things in the NRA. are worth preserving," he maintained. "We should keep the best of it."

Mr. Dunne, who was on his way back to Portland from Astoria, where he was admiral of the regela, stopped off in Vernonia for a couple of hours to chat with friends.
