## Council Orders Change

## **Reduction to Become Ef**fective May 1, Stated; **Resolution** Adopted

City councilmen, Monday eveing, devoted the first part of the irst-of-the-month meeting to placng the official okeh on monthly oilis and then launched into a disussion of a reduction of water ates for users of the water sysem.

A discussion of the present rate and the decision to adopt a reduction was reached so that users vill now be charged less per month han has been the case formerly. To make clear the reduction, civen below is the old rate system f the water department:

During the months of June, July, August and September the rate vas \$2.00 for any amount of vater consumed up to 4,500 galons. During remaining months of he year the \$2.00 was charged for allonage up to 3,000. For overun consumption over the amounts isted above 40 cents per thousand allons was charged for the first 0,000 gallons, 30 cents per thouand for the next 30,000 gallons, '0 cents per thousand for the next 10,000, and 15 cents for all gallonge over that amount.

The new rates to become effectve May 1 will be as follows: Durng the months of June, July, Augist and September a minimum harge of \$1.75 will be made for callonage up to 5,500. For remainng months of the year the charge vill be \$1.75 for gallonage up to 3,000. Overrun charges will be 35 ents per thousand gallons for the
