

(Continued from page 1) averages over \$100,000 a year in addition, the citizens are beginning to realize that they can't possibly expect permanent rate reductionsif any at all- when net earnings of the system for the last ten years have averaged only \$329,890.00 a year and actual gross income is less today than it was ten years ago.

Now with one of the biggest industries moving out of the district skeptical citizens are beginning to wonder how the PUD estimates of \$114,000 increase in revenues this year can come true, particularly when the district is losing a huge payroll represented by 450 steadily employed men and their families and losses to other businesses that these people helped support.
