GASOLINE SITUATION IS STILL TIGHT

The average civilian motorist should expect no increase in his gasoline ration for the next several months, at least not before the end of the war with Germany, the OPA says. Civilian stocks of gasoline built up last winter have been greatly reduced despite increased imports and record domestic production. Civilian grade gasoline stocks have decreased approximately two million barrels in 30 days,

#### ONIONS TO BE PLENTIFUL THIS YEAR

Your hamburger sandwich may have gone without onions last year but now there's no excuse for such a deficiency, because the WFA estimates that this year's crop will be 45 per cent above the ten-year average, 1933-42. For satisfactory home storage select good fully dried onions, keep in a well-ventilated, dry place in temperatures as near to freezing as possible without freezing. Onions store satisfactorily at temperatures from 32 to 55 degrees. Pantry or attic usually is superior to cellar. Never pack onions closely in a closed container. Spreading on a screen placed overhead in a garage or back porch is good if temperatures remain above freezing. Good quality onions will keep several weeks under ordinary room temperatures at this time of
