OPA GRADES

GASOLINE QUALITY

Gasoline sold at service stations and other retail establishments at ceiling prices set for premium grades must meet a minimum octane specificatian of 75, OPA announces. This action has been taken to protect buyers from any attempt to sell lower grade gasolines at higher ceiling prices established for premium grades. OPA said most sellers are offering premium grade gasoline having an octane rating not lower than 75. The announcement pointed out that at present the petroleum administration for war does not permit manufacture of gasoline for civilian consumption as premium grade to exceed 76 octane, a step necessary to maintain milntary supplies of higher octane fuels.

GIFT MAILING DEADLINE SET

December 1 is the deadline requested by the Post Office Department for mailing Christmas gifts in the United States. Every citizen who is playing Santa Claus for loved ones and friends in other towns is urged to get that present in the mails by that time. to insure proper delivery. The reason, say postal officials, is that Americans are expected to mail domestically 25 per cent more gifts than a year agoand at a time when the post office has fewer employees and less well-trained holiday help than ever before. In addition, the fact that more people have moved to different addresses to do war work is expected to mean that the average distance traveled by each gift will be greater than before the war.

CHRISTMAS STREET LIGHTING BANNED

The office of war utilities of WPB is asking city officials, civic clubs, chambers of commerce, merchants and citizens to dispense with outdoor lighting this Christmas, as was done in 1942 and 1943. Object of the request is to reduce electricity consumption and coal requirements. The fuel situation in most areas of the country is critical and strict

RECONVERSION JOB GIVEN INDUSTRY

'The job of reconversion, when it comes, will be put up to industry squarely and with a minimum of interference from Washington," declared Edward R. Gray, assistant vice-chairman for civilian requirements in WPB at a Boston meeting of the national retail furniture association. Pointing out that government had to step in two years ago when war conversion was the prime essential, Mr. Grey said that "some day Government is going to be able to say to manufacturers, you've done your war job. Get back to making your peacetime products. We'll help you where we can, but this job is yours. And I am confident that industry will accept this challenge gladly and will do the job bette rthan any of us in Washington could plan it."

20 FOREIGN COUNTRIES

Since Poland was invaded in 1939. Americans have given more than \$175,000,000 to more than 20 countries, the president's war relief control board reported in calling attention to the second national war fund drive conducted during October. Before the control board, was established 700 agencies were appealing to the public for support. Now only 110 agencies are authorized to engage in foreign and domestic war charity. The \$250,000,000 fund this year is expected to aid 60 million persons.

RULES GIVEN FOR PAPER SAVING

When salvage paper is collected, to avoid fire hazard, the department of agriculture recommends that it be stacked neatly and tied in bundles. Paper boxes should be flattened, then tied in tight bundles. A metal trunk or bin with a tight cover is the safest place to store paper. Next best is to stack paper bundles on a cement floor away from furnace, stove or hot pipes. Soiled or oily paper is useless for salvage and is also a fire hazard and should be restroyed.

TOBACCO CONSUMPTION

NEARS RECORD While domestic tobacco consumption in recent months has declined this has been offset by shipments to armed forces abroad so that overall consumption is at or near the highest in the history of the industry, the department of agriculture reports.

PLANT OPERATES WITHOUT MEN

The women have it all their own way in one Melbourne, Australia war plant. Now entering its fourth year of operation, this plant is run entirely by women, ages 25 to 40. Most of the women never worked outside their homes before they took their present jobs. Among other things manufactured are steering gears, gun carriers and telescope holders for artillery. Technology has made it possible to operate heavy industry with a feminine touch.

ROUND-UP OPA says-More than 88 million persons live in rent controlled areas. . . Farmers will pay about 40 cents a hundred pounds more for dried beet pulp and molasses pulp as a result of the new ceiling prices . . . Highest retail prices for cranberries is expected to be about 41 cents a pound, since ceilings have been revised due to weather damage to the crops.

The Department of Agriculture says-Total feed grain supplies for the 1944-45 feeding year are estimated to be third largest on record. . . . The aerosol bomb method of combatting mosquitoes, which in 10 seconds can release enough poison to kill mosquitoes in a large room, shows promise for household use against flies and for protection of certain truck crops.
