West Teams Win Second Jamboree Try Tuesday; Loggers Trounce Parkrose

Tuesday evening, September 8, brought a large crowd to the John Gamm field located in St. Helens to witness the second Lower Columbia League jamboree to be played. The East teams of the county opposed the West squads and the West went on to repeat last year's performance by defeating the East by the score of 18-7 in a grand total of 64 minutes of action-packed football. The weather was perfect and games close, making the jamboree a complete success as far as the crowd of 2500 from all over the county was concerned.

About 160 players of both East and West teams participated in this annual classic. Team captains drew out of a hat to determine their opponent and in what order they would play. Drawing results with the West mentioned first and the order in which they played were: Seaside vs. Rainier; Clatskanie vs. St. Helens; Vernonia vs. Parkrose and Warrenton vs. Scappoose.

A summary of each game in the order in which they played is as follows:

SEASIDE VS. RAINIER

Seaside won the toss starting the annual LCL jamboree and elected to receive. The over-anxious Gulls fumbled the kickoff on their 35 where the Rainier eleven recovered. The Columbians, combining a passing and hard running attack, drove all the way down to the West team's 9-yard stripe where they fumbled with a Gull recovering. Seaside, failing to get a first down, punted on fourth down to the Columbians where a Rainier back fumbled with the coast team once again coming up from the bottom of the pile in possession of the pigskin. The recovery ended the first quarter of play.

The second quarter was a seesaw battle between the two squads with neither one penetrating too deep into the other's territory. Game end and score was 0-0, which was the score also for the East and West teams.

CLATSKANIE VS. ST. HELENS

Clatskanie won the toss of the coin in the second tilt and received on their own 26 and carried to the 35. The big St. Helens line was too tough for the Tigers so with fourth down they kicked to the Lions 30 where it was picked up and returned to the 47. St. Helens, keeping strictly to the ground, ran the ball from that point the full length of the field for a TD. Try for point was no good, but an off side penalty against the Clatskanie eleven enabled the Lions to try again, this time making the counter. The rest of the quarter was uneventful.

The second quarter revealed several St. Helens drives into the Tigers' territory, but each time the Clatskanie team would rally and hold the strong East squad. Game end revealed the Tigers on the short end of the score 7-0 with the East sporting the advantage in total score leading the west by the same total.

VERNONIA VS. PARKROSE

Vernonia vs. Parkrose was next on the agenda with the locals winning the toss of the coin. The Loggers received the kickoff on the 20 and Lusby carried it to the 31 before being downed by a Parkrose tackler. The Loggers offense seemed not to be able to get started and they kicked on fourth down. Billy Braun got off a beauty which, including the bounce, traveled 69 yards to the Broncos' 17. Parkrose then drove the ball up to the 26-yard stripe in three plays and elected to gamble and run fourth down, but a solid Logger wall stopped the Parkrose back and took over on downs. On the second play from scrimmage Homer Fuller sneaked around left end and got all the way down to the five before being stopped. An offside penalty on the next play put the locals back to the ten. On the next play a spot pass from Drips to Nanson

was good for the locals' first TD. The try for point failed.

The Loggers then kicked off to the Parkrose eleven which elected to take to the air. A toss by the East team was intercepted by Drips and once again the Loggers took over on the Broncos' 33. First quarter end revealed a pass from Drips to Nanson once again, this time to the 19 and good for a first down.

Second quarter play started with Braun around right end to the one from which point Drips drove to the three. A handoff from Braun to Fuller put the pigskin on the one from which point Drips piloted-driven over the second TD. The try for point again failed. The rest of the game was played on the most part by the Logger reserves and the only real threat of the game by the Broncos was stopped on the locals' five. Game end revealed the West teams leading the East 12-7.

WARRENTON VS. SCAPPOOSE

The next game on the schedule and final tilt was the big surprise of the evening when Warrenton pushed mighty Scappoose all over the field. The Warriors played this entire game in the Indian's territory except for a brief moment when the Indians managed to get into the fighting coastal teams' territory. The Warrenton eleven tally came with but two minutes

CURB, WALK BIDS ASKED FOR SCHOOL

Another step towards completion of work at the front of the high school property will take place when the board of the district opens and awards bids for cement sidewalks and curbing in front of the building.

The board, which met Wednesday evening, issued a call for bids as part of their session that night. The bid call provides for contractors to submit prices for curb and walk in front of the building only and prices for curb and walk along the entire school property from the Vernonia Auto company to the grade school property.

The board expressed its appreciation to West Oregon Electric and Manager Guy Thomas for providing a reduced rate schedule for use of the new field lights. The reduced rate will provide electricity for the lights at the cost of the power to the Cooperative.

Members of the board inspected new equipment added to the building within recent weeks during their evening meeting.

Book Stock in Library Rises

Both the number of books available for use at the city library and the number of registered borrowers increased during the past year as indicated by the statistical report prepared a short time ago by Mrs. Paul Gordon, librarian. The report was placed before the city council Tuesday evening and covers the fiscal year ending June 30, 1953.

At the beginning of the year a total of 646 patrons were registered and to that figure 58 were added during the year and 28 were removed to leave 676 at the end, an increase of 30.

The stock of books at the beginning of the period totaled 2361 and at the end, 2476. During the year 70 volumes were added by purchase, 61 by gift and 16 were removed. The library receives 177 periodicals by subscription and 141 by gift. In addition, the facilities of the state library were patronized with the borrowing of 172 volumes.

Circulation decreased slightly, the report showed. Total circulation for home use amounted to 3954, down 153 from the preceding year.

Oiling Crew At Work on Timber Road

City Streets Next For Workmen; Repair Due Scappoose Road

The county road oiling crew began work in this area Friday noon of last week when they started repairs to the Timber road, according to County Commissioner Clyde Henderson who outlined the work the crew will do before leaving here.

The Timber road work will comprise patching of places where the surface has broken and when completed will be followed by work on city streets. Following that will be heavy repair work on this end of the Pittsburg-Scappoose road for a distance of about four miles, the commissioner said. Ten days to two weeks time will be required for the work scheduled in this area.

The crew has already completed resurfacing four miles of the Apiary road between the crusher and highway 47 and has repaved six miles on the Scappoose end of the Pittsburg-Scappoose highway.

The road crew for this area recently installed a 92-foot long culvert on Beaver creek in the Fishhawk area to replace a bridge. Other work underway is the construction of a fill and concrete culvert which will replace the Keasey bridge on Rock Creek.

A change in the administration set-up now places Commissioner Henderson in charge of the Scappoose, Dutch Canyon, Bachelor Flat, Chapman and Sauvies Island areas in addition to this valley. He pointed out that tax payments this year have been slow and that county road work has been hampered as a result.

Classes to Tell Sanitation Need

A series of classes for restaurant operators and others who serve food for public consumption will be held in Columbia county September 14, 15 and 16 under arrangements made by the county public health office.

Ben Rinehart, county sanitarian, said emphasis will be placed on kitchen sanitation. The classes will be the first of their type to be held in the county.

The Oregon state board of health is co-operating in sponsorship of the 90-minute classes. Rinehart said. A movie, "Best Food in Town," is scheduled as well as demonstration to show up-to-date food industry techniques.

The classes are intended primarily for restaurant, cafe and school cafeteria employees Rinehart said. Cards will be issued to those attending.

Schedule for the classes is: September 14, Clatskanie grade school, 2 p.m.; Rainier city hall, 8 p.m.; September 15, St. Helens courthouse, room 206, 2 p.m. and 8:00 p.m. and September 16, Vernonia, Washington grade school, 2 p.m.

FAMILY AWAITS SON'S ARRIVAL FROM KOREA

Mr. and Mrs. Turner Daniel and family, Treharne, are anxiously awaiting the arrival of their son, Sgt. 1/c Orville Daniel, who, at latest word has shipped out for home after being released last Friday as a prisoner of war held by the North Koreans.

The family is planning to drive to California to be present when their son docks. The sergeant was captured December 1, 1950, six months after arriving in Korea and since that time 24 letters have been received from him. He was able to walk across the separation line when released, indicating that his health may be good after the long captivity.

Tentative plans for celebrating his homecomings were being talked here earlier this week by members of veterans organizations although he was not a resident of Vernonia when called into service. The family moved here from Yakima.

Other members of the family besides his parents are: a brother, John Lee; two sisters at home, Ruby and Caroline, and four other sisters, Mrs. Nora Eikenberry of Selah, Washington, Mrs. Imogene Euteneier, Yakima, Mrs. Audrey Phillips, El Dorado, Arkansas and Mrs. Geraldine Baker, Houston, Texas.

\$185,000 Loan Granted West Oregon Co-op

Notes Signed by Board of Directors Tuesday Evening

The principal item of business to occupy the directors of West Oregon Electric at their September meeting Tuesday evening was the signing of notes that will bring this Cooperative a loan of \$185,000. Part of the amount will be used for new line construction and the remainder to provide deficiency funds for right-of-way and construction work approved in prior loans.

Of the total, Cooperative Manager Guy Thomas explained that \$86,500 is earmarked for the construction of 30 miles of new line which will be designed to serve 45 consumers in the Wilark and Tronholm areas.

The signing of the notes Tuesday evening makes it possible now for the Cooperative to secure the remainder of easements needed for the new line and to take care of right-of-way clearing preliminary to calling for construction bids early next year. The line is scheduled for completion next summer.

As another part of the Tuesday meeting the directors authorized the two nominating meetings for directors whose terms expire this year. The terms for district 2 and 5, Noble Dunlap and Guy Griffith, end and the nominating meeting will be October 1 and 2 at the Natal and Vernonia granges respectively.

The board was also informed by the manager that the present transmission line construction job awarded to Estep Line Construction company of Yakima earlier this summer is well underway. This 16.3-mile line will connect the Sunset substation to the Jewell-Elsie area and provide better service there.
