Grade Budget Tax Levy for Year Drops

School Meeting Due March 9 on Proposed 1955-56 Cost Sheet

Prepared at the official budget meeting Tuesday, February 9, and published this week is the proposed 1955-56 budget for school district 47. The listing of proposed expenditures will be presented to voters of the district at the annual meeting March 9.

The expense and income sheet for the coming fiscal year shows some changes, first of which is an increase in the amount of money expected from sources other than property taxes. More money will come from the basic school support fund to account for over \$8000 more estimated receipts for next year than was received last year.

The budget list of expenses also shows an increase from \$155,990 last year to \$163,350 this year, made necessary by the need to employ two new teachers to handle a steady enrollment increase in lower grades and to raise teacher salaries.

Enrollment at the end of the last school year stood at 509 while this year the figure is 537 and a further gain is expected.

Another change in the expense list calls for a reduction of \$900 for the school lunch program leaving \$1000 budgeted as a reserve fund for this item. Present plans for the lunch program specify that it is to be self-sustaining.

Residents of the district, however, will face a lower tax bill on property than they had last year. The 1954-55 budget listed an amount of \$73,012.02 to be raised from taxes, while the proposed new listing calls for taxes totaling \$71,996.80.

Approximately 15 teachers from the local schools attended a dinner meeting of the Columbia County Education association at McBride school in St. Helens on Monday, February 14 at which about 125 teachers and their wives or husbands from all over the county gathered for the annual social night. A variety program was presented by groups from the Rainier schools and bingo was played afterwards.

Business conducted consisted of the election of the following officers for the coming year: Darold Proehl, Vernonia, president; Mrs. Edith Ingald, Rainier, vice president; Mrs. Evelyn Heath, Vernonia, secretary and James Johns, Vernonia, treasurer.

Over-Expenditures of Welfare Funds Noted in Report from Commission

According to information released by Mrs. Eva L. Tice, administrator of the Columbia county welfare commission, Columbia county completed the first half of the fiscal year with a total net over-expenditure of \$1,803.43, which included an over-expenditure of \$257.60 administration expense.

The items over-spent constitute a serious threat to further expenditures, inasmuch as shortage of state funds are limiting transfers from one program to another.

An effort has been made to curtail assistance by eliminating help to persons able to work and by limiting medical care to emergencies only. Both restrictions must be tightened until costs are within funds available.

Some help has come from service groups, church auxiliaries and individuals. (Again Colum-

Fees Listed for Golf Course

Lloyd Quinn, new manager for the Vernonia Country club, issued a statement Tuesday which listed fees for the club for the coming season and announced the date of April 17 for the J. A. Bush Jr. spring handicap.

His schedule of fees is: family membership including children under 18, \$50; non-playing membership, \$25; green fees, 60c for nine holes, \$1.20 all day; green fees, under 16, 35c nine holes, 70c all day; rental clubs, 50c day; junior membership, grade and high school students, \$15; college students membership, \$25; out-of-town guests with member, \$1 day.

The high school golf team, which will be coached by Bill Johnson, will play free, on week days, but pay the regular rate on week ends or holidays, or, if holding a junior membership, will be allowed play anytime.

Work on the course will start this week end and Mr. and Mrs. Quinn will be assisted by Mr. and Mrs. H. J. Buffing in the operation and maintenance.

Planer Added to Mill Operation

Custom planing of lumber is a new service that has been added to the saw mill operation owned by Jim Smith, he announced earlier this week when he outlined the work it is now possible for his mill to produce.

He emphasized custom work for farmers or anyone else having logs which they wish processed. With addition of the planer, he makes available a complete sawing and refinishing plant, the only one in the valley where an individual may bring his own logs and have them cut to order.

The planer can surface timbers up to 4 by 10 inches and up to 18 feet in length.

2700 Pounds Of Seed Now In Storage

Tree Farm Men End Cone Processing Job; 6000 Bushels Collected

Crown Zellerbach reports completion of the processing of tree seeds from cones collected by all tree farms of the company in western Oregon and Washington. The local Columbia Tree Farm each year extracts the seed from the cones and cleans the seed for all divisions of the firm. This year more than 6000 bushels of cones were processed to procure a total of just over 2700 pounds of clean seed.

Seed is sent to Portland for cold storage until needed for seeding in the tree nursery at Nisqually or for direct seeding on areas needing seed.

Species of seed cleaned this year included Douglas fir, western hemlock, sitka spruce, noble fir, silver fir, grand fir, and western red cedar.

The cones were collected last fall, dried to make them open and then the seed extracted. The extracted seed must be carefully cleaned to produce a high quality seed with top germination test.

Local crews have been working at the seed cleaning since early November.

Sales in Oregon in January totaled \$5,481,659 as compared to \$3,602,118 in January of 1954. Columbia county sales last month were \$59,903 as compared to \$46,435 a year ago.

Court Given Statement of County Funds

Road Work Expected To Deplete Fund by End of Fiscal Year

Columbia county finances were reported a few days ago to be in good condition according to John W. Whipple, county judge. Tabulations from a financial statement furnished the court by the county clerk show that the general fund amounted to \$388,058.00 as of July 1, 1954, had an unexpended balance at the half year mark of \$224,207.06, and with six months of the fiscal year gone the general road fund had an unexpended balance of \$211,140.03 against an original budget of \$347,167.40.

The Judge points out, however, that heavy road repair and construction as well as commitments for the purchase of necessary road machinery and repairs for the remainder of this fiscal year will probably deplete the balance in the road fund.

"A determination to keep the county budget in balance will make it necessary to forego improvements and facilities requested by different groups of our citizenship", the Judge said.
