For over six years now, we have told our friends and anyone that was interested, that we had had golfers on the course every Christmas and New Years for the past six years.

THE PUBLIC WELFARE ?

Questions about public welfare which are of general interesa are answered in this column as a public service. Help with individual probfare office.)

I got a lump sum check for social security this month and I already had my welfare check. What should I do?

If your social security benefits will not be enough to meet your needs on a continuing basis, you have the choice of arranging for your case to be closed until you have used up the lump sum check you have received or simply refunding the lump sum to the welfare department and having your assistance grant continued. You should tell your caseworker immediately that you have received your social security check and give him the amount. If you wish to refund the money to the welfare department, it is advisable to bring it to the office since caseworkers are not permitted to accept reimbursement in the field.

Why is public welfare getting involved in birth control? Shouldn't this be left up to the individual?

Many families who might wish to make use of such information do not know where to obtain help with family planning and are not aware of the policy which permits caseworkers to make referrals to facilities which offer these services. The recently established public welfare policy directs caseworkers to inform recipients of whatever facilities are available and to offer referral in case the family wishes to accept it. No family is required to accept these services.

My neighbor is applying for assistance and owns a dog. Who will pay for the dog food?

Unless she is blind and requires a seeing eye dog, it will be up to the neighbor to decide whether she can manage the expense of feeding her dog out of her assistance grant or not. Public welfare will not require her to give the dog away but will not be able to make any allowance in her grant for this expense.

Do old people have to work for their welfare checks?

Only employable persons are assigned to public welfare work programs. Aged or disabled people are not required to accept work assignments.

I contribute to my elderly mother but my brother doesn't, can I force him to do his share?

him to do his share?

If his income is such that he is liable for a contribution to your mother under the law he can be compelled to make a contribution regardless of the amount for which you are liable.

My neighbor gets aid to the disabled but seems perfectly healthy. How do you decide whether a person is eligible for this kind of help?

Eligibility for Aid to the Disabled is determined on the basis of a review of all pertinent medical information, along with facts such as age, training and work experience. Many disabled people have conditions which are not outwardly apparent but which prevent them from engaging in any kind of gainful employment that they know how to do.

Should I drop my hospital insurance when I am old enough to qualify for medical assistance for the

MAA beneficiaries are encouraged to keep their present health insurance policies. Such insurances, in combination with MAA, may provide a broader range of services to the beneficiary. Insurance benefits are, of course, used first in providing care. MAA picks up where they leave off in paying for eligible services. In applying for MAA, beneficiaries agree to assign their insurance benefits to assure that they are used for their intended purpose—meeting doctor, hospital or other medical costs.

What should I do if I have information about someone who is cheating on welfare?

Either contact your county public welfare commission or write directly to the Public Welfare Investigator, Public Service Building, Salem, Oregon.

Representative Talks on Bills

State Representative Grace Peck (D-Portland) outlined proposed legislation for the retarded and discussed a wide range of other bills when she met with CARC last week in St. Helens.

Representative Peck, somewhat pessimistic about any laws being passed that would benefit the retarded, due to the conservative atmosphere in the present legislature, listed four areas of action being considered by the state. One of these is the research conducted by lay, professional and governmental leaders that will be used in planning a long range program for the retarded. The other three areas are:

The other three areas are:

A bill to get an appropriation to continue the day-care center for trainable children in Clackamas county, which now serves 30 children and to get another day-care center established in the state. This would be an extension of HB 1326, passed by the last legislature.

A bill to pay part of the cost of classes for the trainable, ages 6-21, if a school district elects to provide classes (Senate bill 39).

A plan (already virtually approved) to rearrange facilities at the Eastern Oregon hospital with a view to transferring older patients from Fairview. This move would effect 400 patients, and would probably eliminate the waiting period at Fairview Home.

The legislator plugged several other programs, among them legislation to help the emotionally disturbed, which she called "a paramount need." Emotionally disturbed children, said Mrs. Peck, go into the main stream of life not prepared and become involved in a long string of trouble. The suicide, the criminal, the social misfit—these are often the children who didn't get straightened out when they were little. Mrs. Peck told CARC.

In other business Frances Robinson, president, announced that Mrs. Donald Moar of Scappoose has assumed editorship of the monthly news letter published by CARC. Subscription is \$1 yearly.

Mrs. Stenton, teacher at the Columbia activity center, announced that six children are attending the classes held at the labor temple. They range in age from 5 to 13 years.

Gain Noted in Health Fight

Among the brightest chapters in medical history is that which has been chronicled over the past 15 years with regard to the fight to save middle-aged American men from the ravages of heart and blood vessel disease. There has been, since 1950, a 7½ per cent decline in the cardiovascular death rate applying to American males aged 45 through

For the first time, the death rate from high blood pressure and the heart disease it causes is down 50 per cent, while that from stroke has dropped 26 per cent. These dramatic gains more than offset an increase of about 4 per cent in the death rate due to heart attack.

It is significant that the decline dates from 1950, a year which marked the beginning of massive heart research programs supported by both voluntary and tax dollars.

The Heart Fund has been the spearheading force behind the effort. Since the first Heart Fund campaign in 1949, about 100 million Heart Fund dollars have been channeled into cardiovascular research programs. Virtually every gain reflected in the 7½ per cent decline in the cardiovascular death rate for middle-aged men is connected, in one way or another with the Heart Fund.

Never in its history has the Heart association had enough Heart Fund dollars to underwrite all of the research projects deemed worthy of support by qualified experts.
