Also serving on the executive board this year will be Miss Anita Niewoehner, Mrs. Marion Briggs, and Mrs. Robert Robinson, past president.



THE SLOW TRAIN
Have you ever waited for what seemed to be hours while a freight train slowly lumbered across the street ahead of you? Have you ever said to yourself, there ought to be a law?

The city of Pleasantville passed an ordinance prohibiting the operation of any train across its street crossings for periods longer than five minutes.

Sometime after the passage of this ordinance, one of the Short Haul Railroad Company's trains blocked a Pleasantville street for almost fifteen minutes. The city brought a legal action against the railroad company under its new ordinance.

"Five minutes is an unreasonably short time," said a representative of the railroad company. "Such an ordinance disrupts interstate commerce, and as such is unconstitutional."

The trial court found the time limit was reasonable. It decided that the ordinance was valid, and that no unreasonable burden was placed on interstate commerce.

The Short Haul Railroad Company appealed.

Tour Promotes OMSI Addition
Columbia county residents supporting the development of an agricultural wing at the Oregon Museum of Science and Industry will be guests of OMSI Monday evening, January 10, reports Don Coin Walrod, county extension agent.

Bus transportation from St. Helens to the museum and return will be furnished by OMSI. The bus will leave from McBride school at 6:30 p.m. Guests will have an opportunity to see some of the activities of OMSI and will be given a conducted tour by Director Loren McKinley and his staff with coffee, etc., following.

The agricultural wing to be built at OMSI will be the first such program in the nation devoting itself entirely to the agricultural sciences. It will provide a continuing program of education, seeking primarily to acquaint the urban population with the science of agriculture. One-third of the exhibits will be replaced each year with the outgoing exhibits being sent on tour around the state in conjunction with cooperating firms.

Invitations are being extended to all segments of agriculture and to businesses serving agriculture. Walrod suggests those people interested in taking part in the tour contact the extension office so that proper arrangements can be made.

IT'S YOUR LAW

Respect for Law Makes Democracy Live

YOUR LEGAL NAME

Most probably you are never quite sure whether your wife should use your first name, or her own, when signing an important paper.

Perhaps you also wonder whether to put "Mr." or "Mrs." in front of a signature, and you can get all mixed up about a "Jr." or a "Sr." after it. Then what about your middle name or initial?

For centuries, under common law a legal name consisted of one Christian or given name and one surname or family name. The law presumes that every person has a given name and a surname which must be stated in full on any legal document.

The law may pay little attention to a middle name or initial, but it is wise to use either one or the other for exact identification. You must be consistent, too. For example, one real estate buyer was advised to sign all papers by his full name, "William Alton Smith, Jr." to make it clear which of the Bill Smiths was buying the property.

If you are a "Jr." or a "Sr." such description should be used to help distinguish you from namesakes.

As for "Mr." in front of your name, that's not important at all. The same is true for "Mrs.," because it's your wife's own name that counts.

When a woman marries, she takes her husband's family name. Her maiden surname is absolutely lost. Many women incorrectly use their husband's full name, and sign "Mrs. William A. Smith," for example. The correct way is for her to sign her own name and her husband's surname, such as "Joan Marie Smith."

A divorced woman who wants to resume the use of her maiden name may, under some circumstances, have it returned to her by court order.


WANT ADS WORK WONDERS
