# City Acts on Old Building

Prior to the regular business meeting of the Vernonia city council held at the city hall, March 7, a hearing was held, as advertised, on the proposition of declaring the former Nehalem hotel building at Bridge street and Grant avenue a dangerous building. Present were Mayor Thomas M. Hobart, Councilmen L. E. Atkins, Horace Hertel, C. E. Miller and Derl Roberts and Attorney Robert Vagt.

There was no argument presented against the building being declared a dangerous building as defined in Ordinance No. 335. It was moved by Councilman Hertel and seconded by Councilman Atkins, to declare the building a dangerous building and the motion was car-

The owner, Joe Walker, was

down and clean up the premises rather than to have the city go through the legal process of contracting for its removal. It was moved by Councilman Miller, seconded by Councilman Atkins, to grant the owner until April 15 to obtain action. Motion carried. Walker acknowledged his presence at the proceedings as constituting notice of the council's action.

In regular business of the council, a letter was received from Agnes Marie Peterson, secretary of the county committee for the Federal Economic Development Act, stating that because of the improving economic picture in the county, it is possible that the benefits of the act may no longer be available after June 1 of this year but present and asked for time to se- that the committee will accept applications under its provisions until that time.

In unfinished business, it was noted that Mr. and Mrs. Cecil Huff have not yet signed the renewal of their lease of part of the airport land, probably because of their not having been notified that the lease is ready. The recorder will send notification of the fact. The golf course management had not submitted a description of the area of the airport desired for the establishment of a tee.

The planning commission is still working on a listing of undesirable buildings.

Police Chief Earl Ray submitted specifications for a police radio communication set-up. The council voted to call for bids on installation of a radio based on the specifications drawn. It was also noted that a camera has been obtained for the police department.

A report from the cemetery operating committee showed that they had met and had selected Ralph Keasey as committee chairman. The council took action to authorize the drawing of an ordinance incorporating the suggestion from the cemetery operating commmittee that all receipts from the sale of cemetery lots be placed in a perpetual care fund and that the sale price of lots be raised to \$50, \$75 and \$90, depending on the established classification of location in the cemetery.

After hearing a report that paint for the hangars at the airport would cost between \$65 and \$90, the council voted to buy the paint. Former understanding was that users of the hangars would apply the paint.

The council took action to authorize the placing of a stop sign for east bound traffic on Maple street at the intersection with Adams avenue. This is the corner by the West Oregon Electric building and the action was brought about by the illegal cutting of corners which has created a hazard.

The recorder was authorized to determine a suitable size for maps so that a supply may be ordered for the city.

After routine payment of bills, the council adjourned at 9:40 p.m. The next meeting will be March


