The County Court of Columbia County, Oregon, deems it advisable to build a new Columbia County Court House and has, on this date, made and entered an order authorizing the construction of said Court House and, accordingly, the public is hereby notified that a public hearing will be held on the 25th day of April, 1966 at 7:00 o'clock p.m. in the Cafetorium of the St. Helens Junior High School, St. Helens, Oregon, for consideration and discussion of matters pertaining to the construction of a new Columbia County Court House in St. Helens, Columbia County, Oregon, the steps to be taken to provide the funds necessary for that purpose and the proposed location to said new Court House.

The site upon which it is proposed to build the new courthouse is as follows:

The approximate cost of the site of the new courthouse is \$190,000.00 and the approximate cost of the proposed courthouse is \$824,000.00.

The approximate date on which it is proposed to commence construction is the 3rd day of April, 1967. No tax levy is proposed or necessary and no bond issue is proposed or necessary for the construction of a new County Courthouse, or the acquisition of a site. The County of Columbia has the funds necessary for the acquisition of the site and the construction of the new Courthouse in the Special Courthouse Building Fund. The Special Courthouse Building Fund has a present balance of \$1,014,898.00.

# Farm Record **Book Offered**

A new 64-page "Farm Record Book" designed to fit a wide variety of farm and ranch record requirements, has recently been published by Oregon State University. Copies of the book may be purchased from offices of Oregon extension agents, reports Don Coin Walrod.

Over 50 pages of the book are provided for listing of farm receipts and expenditures. Column headings are blank so farm operators can set up the headings to fit his individual farm operation. Adequate space is provided to include information about receipts and expenses such as date, item description, firms or parties involved, quantities, prices and total

Along with printed instructions, the new record book has seven pages that provide other important record keeping information. These include inventories of land, improvements, machinery, and livestock, and an inventory of crops, crops products and supplies. Sections on "Farm Business Summary" and a "Farm Financial Statement" are also provided. Good farm records are just as important as adequate programs of weed control, fertility, or variety selection, says Walrod. Unless a farmer avails himself of one of the electronic data processing systems currently offered farm operators, a record book is a vital part of the farm program.

# THE PUBLIC WELFARE ?

#### 

(Questions about public welfare which are of general interest can be sent to the Public Welfare Help with individual problems is available at your county welfare office.)

Could a mother still get ADC for her children if she could support herself by working?

Need for ADC is determined by computing the total need in the household, including that of the mother and the children and deducting any income. Therefore, if the mother's job were sufficient to provide only a part of the support for the household, Aid to Dependent Children funds could supplement, but her need would not be figured separately from that of the children and she would still be included in the Aid to Dependent Children grant.

If my father moved in with us, how much rent could he pay out of his old age assistance grant? Unless you are also eligible for assistance, no rent would be included in your father's Old Age Assistance grant while he is living with you since you are a legally responsible relative. It is expected that legally responsible relatives who are self-supporting will provide shelter without charge when a welfare recipient lives in the same household.

A friend of mine passed an examination for caseworker, but did not get the job. Why?


A caseworker's job is a very demanding one. It requires an interest in people and an ability to work with them comfortably. Qualities, such as these, cannot be adequately measured by a written examination, and therefore all applicants who passed the examination are interviewed to determine whether they appear to have potential for becoming really good caseworkers. Sometimes, people who have the intellectual ability to pass an examination with a high score, may find in the course of an interview that they are not suited to a job such as a caseworker. What do you do when people get too old to take care of themselves?

Aged, infirm people who cannot take care of themselves can be placed in a nursing home or home for the aged if their condition re quires it. Sometimes these people prefer to remain at home and are able to do so with part time household help. Public welfare can provide such help for them if this seems to be the best plan. In the individual case where the elderly person is confused and unable to manage his money, assistance may be paid through a guardian or conservator appointed by the court.

# **Mental Health Services Told**

The statistical report from the Columbia County Mental Health Clinic to the state mental health division for the month of February shows 68 interviews with clients, 49 with parent substitutes, five with spouses and 14 with other persons who are significant in the life of the client, totaling 126 interview hours. Some of these were evening appointments. There also were three group sessions.

A total of about 43 hours was spent in community service with 27 hours during the regular working day and 16 hours outside the usual clinic time.

The past month, about threefourths of the clinic time has been used in giving direct service to clients and their families and onefourth has been invested in community service, according to Anita Niewoehner, psychiatric social worker for the county clinic.

#### I heard about a woman with 11 children who got \$800 a month from welfare. Could that be?

No. The grant for a family of that size would be somewhere around \$400, if the children were approximately evenly distributed in age from birth into the teens. It would be somewhat less if they were all under age twelve, and somewhat more if most of them were older.

I have a disability which prevents my following my former occupation. Can I get aid to the disabled?

Not unless your disability is such that it prevents you from engaging in any gainful employment. If you are able to do some type of work by which you can support yourself, you would be expected to accept this type of work, even if it were not in your usual field.


Is it true that a lot of people work and get a welfare grant besides?

If earnings are not sufficient to meet needs at public welfare standards, the agency can supplement earnings to make up the difference. Employed persons are allowed to keep a certain amount of earnings, ranging from \$12 to \$30, depending on the total amount earned in order to cover some of the expenses connected with working and provide incentive toward employment.

What efforts do you make to discourage families from having more children than they can aupport?


Caseworkers are expected to discuss family planning with mothers in the caseload and to offer them referral to a medical facility for birth control if they wish to accept this referral.
