School Marks Opening of 71-72 Activities

Schools of Vernonia School Dis trict 47J will open August 30 this year for the 1971-72 school year. Prior to the opening date new teachers will meet August 25 with the administrative staff. August 26 and 27, the total staff will meet for an in-service and preparation for the opening of school.

Five new teachers are joining the staff of the schools this year. At Vernonia High School, Leith Hawks will teach chemistry and the physical sciences and be as-sistant football coach, Doug Wilson and Michael Taylor will be working in the industrial arts and vocational education programs. Taylor will also be head wrestling coach.

In the elementary schools, Rosemary Arterburn will teach kindergarten and Sandra Carmienecke will teach fourth grade.

School offices will be open be-ginning on August 23 for all par-ents desiring registration information Formal registration for high school students will be Thursday riday, August 26 and 27. Registration for elementary students new to the district will be the Washington School office Friday, August 27.

Time The regular meeting of the City Council of Vernonia was called to order by Mayor Fisher Monday evening, August 16 at 8 p.m. Councilmen Tomlin, Keasey and Banta were in attenance. Councilman Ro-berts was absent. City recorder William Nelson also was in attendance.

The majority of the issues to be brought before the council were either tabled or turned over to committee. Only two issues were brought to a conclusion.

After the reading and approval of the previous meeting's mintaken up. Sam Potter representing property owners along the south portion of Weed avenue complain-ed of a drainage problem. Potter stated that the ditch on the west side of Weed is not adequate to side of Weed is not adequate to carry the water during the rainy spells and that the water ran across the roadway and through his and neighboring yards. The city maintenance crew is to investigate the problem.

Albert Tandy then asked the council for permission to fence along a ditch that runs adjacent to his property to protect his cat-The city granted him permis-

tle.

Tandy also asked some questions of the city council regarding the building code and was given the information he requested. He further stated that the roadway to the water plant was being washed away by the river. The city said they would contact the state to see if the state could be of some help. Later in the meeting Larry Bair also brought up some business from the floor. He requested that he be allowed to erect a double unit mobile home on a solid foundation. The home was to be placed near his place of business on Rose Ave. Bair said he felt that this particular type of unit would be classed as a "modular or pre-fabricated home" rather than a mobile home. The overall dimensions would be 24 feet by 68 feet. Bair further stated that the home met all of the requirements of the state building, plumbing and elec-trical codes. Bair told the council that the unit would be put on the county tax rolls rather than licensed as most mobile homes are. The council said that they would seek legal advice from the city attorney before making a decision. There were no committee re-ports made at the time the mayor called for them.

Longtime Public Servant Passes

Acel D. "Ace" Lolley, 71-yearold former police officer and Police Chief in Vernonia for twentyseven years before his retirement and who had currently been serving the city as Justice of the Peace, died very suddenly early Sunday morning, while visiting at the home of his sister in Weiser, Idaho.

Funeral services were held at the Fuiten Mortuary Chapel, Ver-nonia, Wednesday, August 18 at 2 p.m. with the Rev. E.V. Gro-gan, pastor of the St. John's Christian Church officiating Mrs Christian Church officiating. Mrs. William Kretschmer was soloist with Mrs. Lloyd Thomas, organist. Concluding rites and vault inter-ment were at the Vernonia Memorial Cemetery with Larry Ber-nardi, Warren Aldrich Earl Ray, Claude Sahw, Fred Roediger and Roy Wilburn serving as pall bearers.

Mr. Lolley was born at Weiser, Idaho April 20, 1900 and spent all of his early life and received his education there. He was united in marriage to Iva Attebery at Wei-ser on March 1, 1919 and they lived their early married years there and then moved to Lime, Oregon for two years before coming to Vernenia in 1925. He owned several businesses including a bicycle shop, service station and a TV and radio shop. More and a TV and radio shop. Mr. Lolley worked for the Grawford Ford Motor Co. in Vernonia for ten years and then went into the police department where he spent twentyapril twent where he spent twenty-seven years before retiring in April 1965. After the death of Os-ear Weed he was appointed Justice

of the Peace by Governor Mc-

Call and was currently serving on his own elected term in office. Mr. Lolley worked on radios from the early years of crystal sets into working on television. He was also a ham radio operator and worked and enjoyed this hob-by to a great extont. He also did by to a great extent. He also did considerable gun smithing as a hobby. Mr. Lolley was a longtime member of the First Christian Church in Vernonia and he and Mrs. Lolley were honored here two Mrs Lolley were honored here two years ago when they celebrated their Golden Wedding anniversary. Surviving is his wife, Mrs. Iva Lolley, Vernonia; three daughters, Mrs. Ted (Marjorie) Bellingham, Astoria; Mrs. Don (Kathleen) Tif-fney and Mrs. Bud (Barbara) Wei-gand, both of Vernonia and aight gand, both of Vernonia and eight grandchildren. Another daughter, Darrah, preceded him in death in hor abildrend her childhood.

Camp Wilkerson Lodge Growing; End In Sight

Plans are growing for the new Camp Wilkerson Lodge building-and so is the structure. County Commissioner A.J. Ahlborn reorts that two builders have offered their services to aid in framing in the main lodge roof.

The pair of experts volunteering for the job are Mel Harper of St. Helens and Leonard An-derson, owner of the Portlandbased construction firm of Franklin Anderson, Inc.

After a conference the past Saturay, the men, along with Ahlborn and designer Stuart Johnson, plan a concerted effort the next two weekends-with hopes that the lodge will be ready for fireplace and roof work by September 1.

Ahlborn reports that Harper and Anderson-and some of their key personnel-will be on hand to guide the chainsaw operators in cutting and fitting the rafters. Anderson plans to camp out at the wilderness site for the pair of weekends. A real need is felt for workers to aid the builders, and Ahlborn
