Wages Highlight Meeting, Increases Granted

It was a far-from-dull meeting when the Columbia County Budget Committee reconvened at the request of the Board of Commissioners following receipt of additional O&C funds, and the necessity for considering the proposed salary increases resulting from union negotiations.

Present were members of the Board of Commissioners, budget committee members, secretary Gloria Salvey (deputy clerk), Circuit Judge Don Kalberer and District Attorney Robert Lucas

The meeting was opened by Commission Chairman Fred Foshaug, who stated that there had been a tentative allocation of the additional O&C funds, amounting to \$151,000, with \$51.-000 assigned to the General Fund and the balance-\$100,000-to the Road Fund.

Foshaug also said that a tentative agreement had been reached with the union, with a \$35 across-the-board monthly increase, which amounted to 51/2 percent. There is also a built-in step increase of approximately 31/2 percent, which made an overall increase of roughly nine percent with an additional \$1,000 of life insurance coverage.

Prior to turning the meeting over to M.B. Morton of the budget committee, Foshaug advised those present that the board had requested the committee to make a decision regarding salary increases for elected officials.

Following a discussion as to whether the commissioners' positions were full- or part-time employment, with the conclusion that with the ever increasing meetings, etc., it was definitely full-time, the commissioners then commented that the additional \$100,000 allocation to the Road Fund was due to the present bridge inspection.

Koch, Foreman." bridge inspection done since 1943, and with the completion of this inspection, there might have to be some bridge replacement, as well as a number of repairs, with bridges on school bus routes, taking first priority. After a discussion regarding

union bargaining for all emplo yees, regardless of the fact that only a very small percentage of the employees were union members, the meeting "livened up."

Judge Kalberer felt the current salary received by commissioners was insufficient with the comment that it should be based upon the position rather than the office-holder.

District Attorney, Robert Lucas stated he would like the budget committee to set reasonable salaries for the commissioners, since the positions were, in essence, full-time, and felt the salary should range in the \$18,000-\$20,000 bracket, with the comment that, if the budget committee felt the positions to be only part-time, salaries should be adjusted accordingly.

E.T. Johnson stated that whenever a candidate ran for office, he was fully aware of the salary involved and that the candidate would run for office more to be in public affairs than for the money involved. He said he was against the suggestion made by Lucas and felt that if such salary increases were granted, the members of both the committee and board would be subjected to considerable criticism.

It was the opinion of Judge Kalberer that a small salary would serve to entice candidates unqualified for the position while a larger salary would tend to attract more desirable candidates for office, adding that it was worth considerably more than what is paid considering it should be a full-time position, with Commissioner Ahlborn stating that if all the duties required were fullfilled, it would certainly be full-time.

After Lucas stated that the board could override the budget committee's recommendations, although he felt it wouldn't be a good idea, things began to heat-up as Morton questioned other departments, as to whether those elective positions should be considered full-time.

Commenting on meetings held nerein the bud committee recommendations were that neither the county clerk nor the district attorney were entitled to a salary increase considering the "large amount of time neither were in their office," Morton took a left jab at the news media. as he added that it was the committee's hope last year, that the feelings of the members of the budget committee would be published in the papers so that the citizens of the county would know they felt there was a definite lack of supervision in the two departments

Lucas came back with the fact that he had received a letter last year, similar to one addressed to the clerk, adding that he had been extremely upset by it and had seriously considered libel action being taken at that time.

With that, Morton commented that in such a case, it might become necessary to utilize outside legal counsel and once more slapped the press as he stated again that he had hoped this information would have been publicized last year.

Johnson then stated that this was the reasoning behind the formation of the Charter Study Committee.

Lucas then helpfully suggested that it might be aidful to reduce the county clerk's salary as a result of frequent absences and inattention to supervision of the office, adding that he felt the
