Forty-six people were killed in Oregon traffic during June, increasing the state's 1973 traffic toll to 290, according to the Motor Vehicles Division.

Degree Added By Member of Juvenile Dept.

Lee Vaughn, counselor for the Columbia County Juvenile Department, recently received his Masters Degree in Law Enforcement (Counseling) from the University of Portland and by doing so, he helped put the county in a unique, and enviable, position. Columbia County is one of the very few Juvenile Departments in the entire country where all counselors hold masters degrees.

Vaughn joins fellow counselor Rich Wood and Department Director Graham "Tux" Tewksbury in holding the prestigious degree.

Director Tewksbury notes that the additional degree by Vaughn should add more overall expertise to the department. Tewksbury goes on to say, "We are proud of the degrees held in our department, and now our next goal is to add additional counselors to provide better county-wide service than we are now able to offer because of our manpower shortage."

Vaughn, 26, is a graduate of Central Washington State College where he earned his masters. He has been with the Columbia County Juvenile Department for the past 16 months and spent time prior to that as a case worker in the Children's Services Division.

Vaughn is basically assigned to cases in Clatskanie, Vernonia and Rainier but he occasionally receives a case in the St. Helens or Scappoose area.

To emphasize the case load, the three-man department handled 1,021 referrals during the past year and, because of the limited size of the department, the counselors also serve as probation officers for wards of the court. For an example, Lee Vaughn handles approximately 75 on-going cases, in addition to new referrals that come in.

In addition to their other duties, the counselors must handle all phases of referrals as well as talking to cases in detention and counseling with families. Citing the overall work load demanded of the three-man staff Tewksbury reiterates his overall goal, that of adding additional counselors to the Columbia County Juvenile Department.

Witnesses to Stage Series

One of the largest series of religious conventions in history will be staged this year by Jehovah's Witnesses.

The Watchtower Bible and Tract Society in New York has revealed completion of plans for 69 "Divine Victory" international assemblies in 46 countries around the world.

Kent E. Battrick, presiding minister of the local congregation of Jehovah's Witnesses, said most local delegates would attend the convention at the Empire Stadium in Vancouver, B.C. July 4-8.

Battrick made it clear that the conventions are not affiliated with any other religious movement. "The objective of these meetings and the purpose of convening is not remotely related to any other campaign planned for 1973."

Events Varied At Port-O-Fun

But prior to that there will be a no-host dessert at the Village at 7:30 p.m. on Wednesday, honoring former festival royalty. The carnival is slated to open Thursday at Condon School, as will local concession booths. They will be in operation through Sunday, June 15.

The sixth annual invitational softball tournament begins Friday night at both the Little League Park and Campbell Park with games continuing until Sunday.

Following the coronation Friday evening at Condon School, there will be a Queen's Ball at 9 p.m. and on Saturday, the parade.

The Port-O-Fun parade forms at 10 a.m. at the end of Milton Way with the registration booth located near St. Helens Ice and Beverage's warehouse. Judging will be at 10 with the parade moving out at 11 a.m.

The carnival will be open following the parade; then at 1:30 p.m. the Navy Drill Team will perform in Civic Pride park with a concert by the National Guard Band to follow.

The Columbia Riders will hold a horse show at the fairgrounds at 4 p.m.

A dance will be held by St. Helens firefighters that night, beginning at 9 p.m., with proceeds going to the rescue unit fund.

Homicide Tops Police Report

Criminal homicide headed the list of offenses in the June summary report of Vernonia Police Department activities as submitted to the mayor and council under the signature of Chief of Police Jack Cunningham. The case was cleared by arrest.

Other activities of the department showed that 27 citations were given, with seven warnings and one arrest as follows:

VBR's, warnings 3, citations 1; stop signs, citations 1; violation of vehicle laws, five warnings, two citations; DUIL's, two; parking violations, 17; boating violations, 1; disorderly conduct, 1, cleared by arrest.

The report also showed one burglary; one felony theft; four misdemeanor thefts with two unfounded complaints. There was also one attempted arson.

During June four traffic accidents were investigated, two abandoned vehicles reported; two assists at fire calls and one missing person located.

The department rendered aid at three ambulance calls; answered 29 public service calls; made eight assists to other departments and handled 34 miscellaneous complaints.

Six members of the reserve force gave 156 1/2 unpaid hours of service while car No. 130 showed 3,938 miles logged.
