

According to the article, it wasn't "quite cricket" for several reasons among them the fact that the minutes reflected unfavorable on two county officials: DA, Robert Lucas and County Clerk, Roy Nelson; that the pair didn't have an opportunity to answer charges that they were not doing their jobs: and according to one source, and I quote from the Longview editorial: "a portion of the minutes is inaccurate, Lucas

### **Police Report** For Month There were 32 citations and 12

warnings issued during the month of July, according to the report handed in at the August 6 council meeting under the sig-nature of Chief of Police Jack Cunningham.

VBR's topped the list with 12 citations and 4 warnings: followed by parking violations. There were 4 citations issued for stop signs and 2 warnings; 4 violations of vehicle laws; 1 liquor violation; 2 for defective equipment with 5 warnings issued; and 1 excessive noise. Under other violations of municipal ordinances was 1, a vicious

dog allowed to run loose. Six misdeamenors were re-

corded with 2 cleared; 1 burglary; 1 unfounded complaint of assault; 1 attempted arson, cleared; 4 forgeries, cleared; 3 criminal mischief, cleared; two bicycle thefts, recovered; with property valued at \$160 recovered.

There were also four cases of harassment and 1 of criminal trespass with the department investigating 27 miscellaneous complaints.

Three traffic accidents were investigated, 15 business houses found open; 1 missing person, located; and 34 vacation home checks

Public service calls totaled 26. ambulance calls, 3; with assists to other departments, 13; and 4 animal complaints. Six reserve officers donated

210 non-paid hours, while the police car, no. 130 logged 4,130 miles and the truck, 120 with a total mileage for the month of July, 4,250

A special event in the Summer Recreation Program will be a field trip tour of the Crown Zellerbach tree farming operation in the Vernonia - Nehalem Valley area on Wednesday, August 15, of next week, for high school and grade school students.

Transportation will be provided by school bus, and reservations must be made in advance. Those planning to make the tour, or their parents, should contact Pat Goodman at the Scout Cabin during afternoons or June Wilson at 429-7731 no later than noon Monday, August 13 to sign up for transportation reservations. There is no charge.

The tour will begin with orientation at the Crown Zellerbach Pittsburg office, and then go to the sorting yard, which is unique in this field. The tour will then proceed to the logging operation at Mist, with stops at various sites on the way. The tour is conducted by Crown personnel.

The bus will leave the Scout Cabin promptly at 12:45 p.m., so participants should plan on being there at 12:30 p.m. Time of arrival back at the Scout Cabin will be around 4:15 p.m. to 4:30 p.m.

The tour is an unusual opportunity for grade and high school students to see the actual operating of a tree farm and logging industry. Residents of Vernonia and vicinity are used to seeing loaded log trucks, rolling down the highway, but few have had the chance to see what took place to raise those trees, fell and load them onto the trucks. This opportunity is made to the young people of the Vernonia area to learn about the major industry of this community.


