

## U of O Opens Doors For Fall Term, 1973

The University of Oregon opens its doors for Fall Term. 1973, on Sunday, September 16. Predictions, based on admissions, summer registration of freshmen, and experience in forecasting returning students, are that Fall Term enrollment will reach between 15,500 and

If the predictions are realized, enrollment will be higher than the 15,432 enrolled for Fall Term, 1972. That was the highest enrollment in the history of the University.

September 16 is the start of New Student Week, a period of orientation followed by registration on Thursday and Friday, September 20 and 21. Classes start Monday, September 24.

While regular Fall Term clas ses are due to start September 24, the University has had classes in session since August 27 when the Law School started its new semester schedule.

The Law School is the first and only unit of the University to adopt the two-semester year. All other colleges, schools and departments of the University operate on a three-term year.
