

Board of Commissioners

(executed executed ex The Columbia County Board of Commissioners met in scheduled session September 19 with Chairman Fred Foshaug. Commissioner Ahlborn, and secretary Gloria Salvey (deputy clerk) present. Commissioner Minkoff was absent, being out of state.

The minutes of the meeting of September 12 were approved. Miscellaneous claims were

Ted Parent, representative of X-Cote, met with the board and with Keith Thompson, Road-Master to present quotations for application of X-Cote seal for the roofs of the St. Helens shop building, the adjacent storage building, and the shop at Clatskanie. After discussion, the board concurred in awaiting the return of Commissioner Minkoff prior to making a decision on the

Thompson reported there would be a delay in receipt of the concrete bridge from Morris Brothers until September 27. Thompson presented

personnel action terminating James Yowell.

Thompson reported he had been discussing with Shell Oil Company the allocations for gas and diesel products, and requested that because of the change of equipment, the allotment from Diesel No. 1 be changed to Diesel No. 2.

Thompson stated there was to be a Road Advisory Committee meeting tonight, and they would be discussing whether or not to continue the group.

Thompson indicated performance tests were held last Friday, with three employees and three others taking the tests. Eric Carlson had not yet advised of the results.

Thompson reported on a meeting with Dick Riesner, principal of Goble School, who questioned what the school district could do to ask for additional funds for the road department, especially in their district. He was also concerned about the bus situation between the Clark and Lentz Roads, hoping the road could be opened, but if not, either a way

off Columbia or Walker Roads. Thompson discussed the fire on the bridge and damage to the site, indicating this had been done two to three weeks ago, and it had taken this long to determine the vehicle involved. He indicated the damage has been submitted to their insurance

Thompson indicated he had met with representatives of Santosh and their contractor on possibly putting in a culvert under Honeyman Road. He indicated they want to put a 7 x 8 culvert and put in equipment crossing pad. This will be discussed further. Mr. Thompson indicated there would be about a month's construction time, and a

month's detour. Thompson indicated that in about three weeks PGE will be ready to do the overlay to the

Beaver site. Thompson presented quotations received from various companies on sanding equipment. After considerable dis-

Robert Vagt, attorney for Herbert Wolden, met with the board to present a request for vacation of a portion of the A.L. Morgan Road No. 111. This was accepted and referred to Martin Seils for preparation of necessary Resolution of Intent to vacate

Purchase Order 2474, to the 3-M Company for signs was approved in the sum of \$1,341.84, and Purchase Order 2480, to Columbia Equipment Company. was signed for 4 Burch Sanders. Model HO-14, at a cost of \$17,072.00, and 2 FRC-30 Burch snowplows for a cost of \$31.68.00. both plus freight to be billed later, at the estimated cost of \$6.18 per 100

Terry Rahe, Dick Dunets and Ron Reeves met with the board to discuss the proposed contracting of inspection services by the Oregon State Health Division Rahe presented copies of the proposed contracts, together with an estimated county reimbursement sheet. Also discussed was a possible contract with DEQ for sanitation inspections. After discussion, it was concluded that if possible, it might be more advantageous for the county personnel to continue sanitation inspections by the local department.

Reeves discussed the application for Parks and Palm for a barrow pit near the city of Clatskanie, surface mining permit. He was reminded Commissioner Minkoff was going to make a recommendation on issuance of the permit, but was unavailable

at this time Rahe presented a draft of a letter to DEQ regarding subsurface sewage disposal, and the Board agreed to prepare and forward the letter

Rahe also discussed a letter from KATU-2 television, regarding a complaint about a mobile home. He indicated he would forward the necessary action and reply

Order No. 7 was signed directing the sale of certain mineral rights on property located in Section 35, Township 6 North. Range 2 West, which had been requested by Donald William A letter was received from

Gordon L. Patchin and David W. sting a rehearing on the denial of a solid waste franchise for the Nehalem Valley Sanitary Service. The board agreed to the request, and set October 10, 1973, at 11 a.m. as the time of rehearing.

Hot Air Balloonists Set Oregon Races

Many of the nation's top hot air balloonists will descend on the Willamette Valley the weekend of October 13 - 14 and ascend in competitive performance in the first annual Great Oregon Hot Air Balloon Races

Allen C. Stephens of Forest Grove, race chairman for the sponsoring organization, Hot Air, Inc., said at least 25 balloons from all areas of the United States have already entered the competition. Thirty or more are expected by race time

The races are sanctioned by the Balloon Federation of America, a division of the National Aeronautic Association of Washington, D.C.

"Hot air ballooning is becoming extremely popular in many areas of the country. Stephens said. "There will be several entries from Oregon.'

The races will be held on the 62-acre Antique Powerland site at Brooks, five miles north of Salem. Gates open at 10 a.m. and raced start immediately. Admission if \$2.50 for adults

and \$1 for youngsters 12 and under Prize money for the event amounts to more than \$2,000 with an additional \$2,000 donated to
