



Mr. Simons in reference to my November 25th mailgram to Geo P. Shultz-please try equal allocation to all gasoline wholesale and retail outlets. The metropolitan areas where there is public transportation is get-ting so much more gas than outlying areas, where we don't have public transportation. We are all conserving every way possible but we ask-like the truckers-to be treated equally and fairly. This way of allocation would cut down on usage and get gas out where people need it to get to work. My customers, who drive 25-40 miles to work are getting only 6-10 gallons at a time and I have only 600 gallons per day and am out of gas by 3 to 6 p.m. I am closing on Sundays and Wednesdays.
