
#### Witnesses



Crown Zellerbach has report ed that 1973 sales and earnings set new records by a substantial margin, with net income exceeding \$100 million for the first

Consolidated sales were \$1,363,622,000, up 21 percent from the prior year's \$1,124,903,000. Net income of \$102,597,000 or \$4.26 a share, contrasted with 1972 income of \$45,462,000, or \$1.87 a share, before an extraordinary item, an increase of 126 percent.

Net income for 1972 was \$1.49 a share after an extraordinary charge of \$9,113,000 or 38 cents per share, due to shutdown of an uneconomic pulp and paper mill by a Canadian subsidiary.

Fourth quarter sales were \$341,312,000, up 15 percent from the year-ago period. Net income for the period was \$21,796,000, or 90 cents a share, compared with \$12,455,000, or 52 cents a share last year, an increase of 75 percent.

# Flood Caused **Heavy Losses** In Northwest

The harsh, swirling waters that accompanied an eigh-day torrential rampage through the Pacific Northwest in January now have been pinned with a statement of charges.

The rains, together with a rapid snowmelt and run-off, racked up more than \$110 million in property damages, caused 16 fatalities and inudated hundreds of square miles of real estate.

Federal Disaster Assistance Administration Regional Director William H. Mayer in Seattle today disclosed that over \$62 million in federal relief, much of it in the form of grants and loans, will be provided in Washington, Idaho and Oregon to help repair the damage and assist floodstricken families to recover from the effects of the disaster.

FDAA is the agency charged with coordinating and managing federal disaster recovery ef forts, and administers the President's Disaster Fund in Presidentially-declared major disas-

ter areas. The Fund is used to finance reconstruction of State and local public facilities, debris clearance, and to provide temporary housing, disaster unemployment assistance and other emergency help in disaster-torn

In all, Mayer said that more than 3,400 families suffered losses in the January flooding over the three-state area. He said that 3,016 dwellings and mobile homes and 126 farm buildings were damaged or destroyed, and that over 100 businesses were seriously disrupted.

A total of 29 counties in Washington, Idaho and Oregon have been designated for federal disaster aid with recovery work well under way.

A large segment of federal recovery funds have been earmarked for the private sector with over \$23.5 million in Small Business Administration and Farmers Home Administration emergency loans projected to help restore homes, businesses and agricultural operations, and a potential of over \$2.2 million in USDA cost-sharing programs for farmers and ranchers.
