Lute Jerstad To Head Up Scout Program

Lute Jerstad, Portland-based mountaineer-adventurer who's been to the top of the world and back, will head the Scout "Top of the World" Troop Open House program in which new members will be invited into Scouting this fall.

Jerstad, one of the five Americans to climb 29,028 foot Mt. Everest and who took the first motion pictures from the Summit, will speak and show films during a kick-off session Sept. 11 at Beaumont School in Portland. The meeting will launch 400 Troop Open Houses scheduled throughout the 15-county Columbia Pacific Council, BSA, between September 16 and October 19.

New Scouts who register during the "Top of the World" membership enrollment and those currently registered will sign an official scroll which will be microfilmed and placed on Mt. Everest's summit by a future expedition. Each Scout who recruits a new Scout will earn a miniature ice axe to hang from his right pocket button; decals and ribbons related to the theme will also be awarded.

The kickoff meeting will be limited to Scoutmasters and senior patrol leaders from each troop in the Council. They'll hear Jerstad discuss his Everest climb and show segments from movies dealing with that climb and with the basics of mountaineering.

The climber, actor, director, entertainer, teacher, author, who earned his keep as well as his doctorate in theater arts while working as a guide, headed the Theatre Arts department at Lewis and Clark College, Portland, before starting Lute Jerstad Adventures, a unique organization which he heads as president. The company offers organized worldwide summit climbs, expeditions, seminar studies in survival, ice climbing and rock climbing, white water float trips, youth adventure camps and mountain guide services-true adventures ranging from expeditions to unclimbed peaks in the Himalayas to Rogue River float trips. Board of Commissioners

(Memorandum Minutes)

The Columbia County Board of Commissioners met in scheduled session August 28 with Chairman Fred Foshaug presiding. Commissioners Minkoff and Ahlborn, legal counsel John F. Hunnicutt, and secretary Gloria Salvey (deputy clerk) present.

Commissioner Minkoff moved and Commissioner Ahlborn seconded the minutes of the meeting of August 21 be approved. Motion carried.

Miscellaneous claims were approved. Joe Schrieber met with the board to present a petition for blacktopping of the Wondrous Road between the Heath Road and Highway 30. This petition was referred to Sam Hollinger, Roadmaster.

Joyce Burghart met with the board to discuss the fact that necessary data from the Computer Knowledge Corporation regarding delinquent taxes, which was due the end of June, has not yet been received, and she is withholding payments for the contract services because of the delays. She requested the Board contact Computer Knowledge to attempt to expedite the necessary information.

Sam Hollinger, Roadmaster, met with the board, to discuss road department matters.

Hunnicutt advised Hollinger he had received a complaint regarding culvert installation in Panorama Terrace subdivision from Mr. Stocket, who indicated the installation would cause

water to drain onto his property. Hollinger stated the work was not being done by the county crews, and that he would check on it to determine whether the project was being accomplished in the proper manner.

Hunnicutt was requested to prepare a release of liability form for signature by George Divine, as a result of Hazel Grove Road slide which dumped dirt and rock on his property.

Commissioner Minkoff moved and Commissioner Ahlborn seconded Resolution No. 92-74 be signed, designating Agricultural Districts zoned A-1 Rural Areas as per the rules of the Department of Environmental Quality, VI Disposal Areas, Section B, for the purpose of application of said rules in Columbia County. Motion carried.

Hunnicutt discussed with the board a bulletin received from LGPI regarding the Fair Labor Standards Act, and the provisions for payment of overtime. Mr. Hunnicutt indicated he would investigate the matter further before offering an opinion.

Hunnicutt also discussed with the board the pending vacation of a portion of the Swager Road.

Commissioner Foshaug advised he had received a call from Tom Nelson, Wolf and Company, the county's auditors, advising the liens for the Viewcrest Street Improvement project have been improperly recorded, stating they are listed as liens against the property owners rather than against the property itself, and that the payments are not being recorded properly. Nelson forwarded a letter making recommendations for accounting procedures to be adopted to facilitate control of the payments.

Lucile Warren, writer for The Oregonian, met with the board, to interview them on their po-

sitions regarding the recall petitions which were filed.

Rudy Wellbrock, State Highway Division, met with the board, Mr. Hollinger, Phil Dewey, Leslie Tucker, Hank Lucker, and Willard Erickson, to discuss changes which need to be made in the road department road numbering system, so proper recording can be made on the state computers for required information. After a lengthy discussion of the matter, it was concluded the present cost accounting system could be used for state purposes, if the first two numbers were dropped, which do not affect the required information.

Karen Chapman and a photographer from KGW-TV Channel 8 News, met with the board to interview them regarding the recall petitions filed, and to get their reaction to them.

Commissioner Minkoff moved and Commissioner Ahlborn seconded Surface Mining Permit Renewal be approved for Parks and Palm Logging Company (small borrow site).

The board approved the signing of County Counsel employment agreement, as submitted by John Hunnicutt.

Based upon recommendation of Mrs. Miller, Community Health Nurse, Order No. 91-74 was signed transferring the sum of \$525, from Contingency to Personal Health Services, capital outlay, for the purchase of an autoclave (sterilizer).

Commissioner Minkoff moved and Commissioner Ahlborn seconded Order No. 93-74 be signed directing the weed inspector to remove tansy from the property of Charles and Deanna Elliott. Motion carried.

remove tansy from the property of Manifold Business and Investment Inc.

Personnel Action forms granting "cost of living" increases for the psychiatrist and psychologist for the Mental Health department were denied, as being a contractual service.

Commissioner Ahlborn moved and Commissioner Minkoff seconded Mrs. June Simmons, George Hafeman, Earl Seawright, and Don Berkey be appointed to the Columbia County Public Housing Authority, subject to acceptance by each. Motion carried.

Based upon the rules and regulations of the Comprehensive Employment and Training Act (CETA) the following people were appointed to serve as a Manpower Planning Advisory Council, subject to acceptance by each: Vern Arne, Employment office; Wayne Foster, Education; Bessie Carpenter, General Business; Don Walrod, Extension Agriculture; Mrs. Yvonne Wallborn, Interested Citizen Client Community; Mrs. Martina Carpenter, Interested Citizen.

Roy Nelson, Clerk, advised that only one bid had been received for the printing of dog license receipt books, that being of Don Bemis, Printer, for \$225.70 for 6500 receipts. The board authorized Mr. Nelson to accept the bid.

Real Estate Course Set

Recent growth in financial institutions and the tightening of laws concerning real estate licensing has made better training for both escrow and real estate personnel mandatory. In response, Portland Community College has scheduled courses in both fields that fill the need.

For escrow service personnel, PCC in cooperation with the Oregon Escrow Council offers a three term sequence which will begin October 3, at Sylvania: Introduction to Escrow, Escrow Procedures, and Escrow Problems.

Introduction to Escrow classes will meet from 7 to 10 p.m. on Thursdays in room CT A8. Escrow Procedures will not be offered this quarter. Escrow Problems, offered to those who have completed the other two courses of the series, is scheduled from 7 to 10 p.m. on Thursdays in room SS A12d. Each course carries three credit hours and a tuition fee of \$30. Students may register at the first class session.

For real estate personnel who require nine clock hours of real estate related training for license renewal, PCC offers a series of three-hour seminars to be held at Aloha High School, Tigard High School, Cleveland High School, Forest Grove High School, Madison High School, Newberg High School, and Wilson High School. Topics include Titles and Title Insurance, Legal Descriptions of Real Property, Land Platting and Zoning, Property Management and Leasing, and Analyzing Property for Investment.

Licenses may enroll for a minimum of three sessions, of for all five at no extra charge. Registration will be accepted at the first seminar attended. Tuition for the series is \$9.
