IN THE NAME OF THE STATE OF OREGON: You and each of you are hereby required to appear and answer the complaint filed against you in the above entitled suit on or before the expiration of six weeks from the date of the first publication of this summons, or if served personally without the state of Oregon, within six weeks from the time of such service upon you, and if you fail so to answer, for want thereof, the plaintiff will apply to the Court for the relief demanded in her complaint, to-wit:

For a judgement against the defendants, Arthur J. Glover and Vera L. Glover, his wife, for the sum of \$500.00, with interest thereon from April 21, 1926, at the rate of 8 per cent per annum, together with attorney's fees in the sum of \$250.00, together with water assessment paid in the sum of \$33.23, with interest thereon at 8 per cent per annum from March 5, 1927, together with her costs and disbursements and for the foreclosure of the certain mortgage made and given by said defendants, Arthur J. Glover and Vera L. Glover, his wife, to plaintiff under date of April 20, 1923, recorded in Book 7 of Mortgages at pages 420, 421, records of said Malheur County, Oregon, and covering the following property in said Malheur County, Oregon, to-wit:

East half of the Southeast Quarter of the Southwest Quarter of Section 9, Township 18 South, Range 47 East, W. M., save and except a necessary right of way for irrigation ditches and pipe lines, together with a full water right in the ditch of the Ontario Advancement Company appurtenant to said premises and used therewith,

SPECIAL ELECTION NOTICE
KINGMAN COLONY IRRIGATION DISTRICT

NOTICE IS HEREBY GIVEN that a special election will be held on Monday, the 29th day of August, 1927, at the school house in School District No. 61, Malheur County, State of Oregon, and within the said Kingman Colony Irrigation District, at which there will be submitted to the legal voters of said district, the question whether or not said district shall be authorized to enter into a contract with the United States providing for the construction of the Owyhee Irrigation Project by the United States, and the payment of a proportionate part of the actual costs thereof by the said district, said proportionate part of such costs to be determined as in said contract provided and the total construction costs of the district not to exceed the sum of \$18,000,000.

A copy of the draft of said proposed contract approved as to form by the Secretary of the Interior, is on file with the Secretary of said district in his office at Nyssa, Oregon, and may be examined by any interested person. The polls shall be open at 8 o'clock in the morning of the day of said election and be kept open until 5 o'clock in the afternoon of said day, when the same shall be closed.

At such election the ballots shall contain the words, "contract with the United States—yes," and "contract with the United States—no". Said election shall be held and the results thereof determined in all respects as nearly as practicable in conformity with the provisions of law governing the election of irrigation district officers.
