LEGISLATOR DIES SUNDAY AT RANCH HOME AT JAMIESON

FORMER LEADER IN LOCAL G. O. P. DIES SUDDENLY AT HOME NEAR JAMIESON; SERVED TWO TERMS IN LEGISLATURE.

Clarence H. Oxman, representative for Malheur county before the present term of V. B. Staples, died suddenly at his ranch home at Jamieson early Sunday of cerebral hemorrhage. He was legislator for two terms, serving from 1927 until 1931.

For many years Mr. Oxman was a leader in county and local affairs having served as county commissioner prior to his years in the legislature. He was formerly president of the Vale-Owyhee Land Settlement association and a member of the board of directors of the Vale Irrigation district.

Mr. Oxman had taken an active interest in Republican politics and was among the best speakers of this county. He had a host of friends who mourn his sudden death.

Surviving are his widow and one son who lives in Wenatchee, Washington.

Apple Harvest Will Open Here On Monday Next

Harvest of the apple crop, considered of fancy quality in this region, will get under way Monday with the start of picking in the orchards and packing in town.

C. C. Hunt will employ a crew of around 25 at his orchard near Nyssa and at the packing house in town. He states that the government has set a minimum price of 80 cents per bushel on Johnathans and Rome Beauties and \$1 on Winesaps, but reports that some buyers are offering a few cents more.

Other Nyssa growers who report good apple crops are Thos. Coward, H. R. Sherwood, J. W. Fogle, Franklin Fry and the Northwestern Orchards company on the Idaho side.

Owing to spring frost, the usual large prune crop has been materially reduced this fall.

SEPT. 25 WHEAT DEAL DEAD LINE

ALL FARMERS WHO WANT CASH BONUS ON WHEAT LANDS MUST APPLY NOW

September 25th, has been set as the deadline for the signing of applications for wheat contracts under the government's wheat acreage reduction program. As a result, County Agent R. G. Larson desires all wheat farmers in Malheur county who are interested in the control plan, and wish to receive the cash payments therefrom, to submit signed applications by next Monday, September 25.

What to do with land taken out of wheat production is bothering a good many farmers. From Washington comes the advise to summer fallow or plant to permanent pasture.

Acreage contracted for 1934 and seeded to permanent pasture or hay meadow crops can not be used for contracted acreage the following year when such fields may be ready to produce crops for sale. As soon as this point is reached these acres cease to be contracted acres and other and additional acres must be taken in their stead.

PIERCE FIGHTS FOR RODENT FUND Congressman Walter M. Pierce has been advised by the department of agriculture that the appropriation for rodent control has been cut to only 38 per cent instead of 27 as first reported. He also states that a concerted effort is being made by those interested in the control of predatory animals and rodents to get a still larger sum in order that the work may be carried on in a satisfactory manner.
