Wrestlers Ready To Twist Bones

The first match on tonight's card bring All Omar Kourali, Turkish wrestler of note in the ring with Don Mathews. Mathews has been on the last two cards and is very popular with the fans.

NYSSA BOY JOINS ARMY

Major H. D. Bagnall, the Army Recruiting Officer, 332 New Post Office Building, Portland announced today the enlistment in the United States Army of Don Roy Willson, son of Mr. and Mrs. Claud Willson, Nyssa, Oregon.

Willson was tentatively accepted on February 27th at Ontario, Oregon by Sergeant Lee B. Mabie, in charge of Army recruiting for Eastern Oregon, and was forwarded to Portland on the same date with Joe Preston Cloud, son of Joe H. Cloud, Route 2, Payette, Idaho.

Both boys were enlisted at Vancouver Barracks Washington on March 3rd. The Nyssa youth elected to serve with the Coast Artillery Corps in the Philippine Islands while the Payette youth elected to serve with the Air Corps at Hamilton Field, San Rafael, California.

Major Bagnall also announced that the Nyssa youth will sail within the next 30 days for the Philippines via Hawaii and Guam and that he will return to the United States after the expiration of two years in the Islands via China and Japan.

Nyssa Antique Collector Has Many Rare and Unusual Pieces of Furniture

No prearranged interview was necessary for this review of Hobbies. These antiques, of which I am about to describe, are childhood associates, for very often as a babe these same pieces held me, from infancy, lulled to sleep at mothers breast or upon daddy's knee, hearing tales of long ago, till now, in turn, my baby is held in these same treasured pieces.

For those who do not already know this collection of antiques belongs to Mr. and Mrs. C. W. Rice, my parents.

Most of these antiques have been in the family for many years. A very few have been added to make this interesting assortment more complete.

The most unique article in our house is an old, solid mahogany, combination settee and dining table, patterned from the old Suttle Chair of ancient origin. This must be seen to be appreciated. The arms of this seat turn back on leather hinges disclosing a groove in which rollers in the back of this settee roll forming a table. To explain further—after turning back the arms, one needs only to take the back of the settee in the middle, facing the seat, pull forward until the back is flat in the grooves; slide along until they rest in the proper place then one person at each end can pull this extension table (as it has now become) to the great length of 11 feet. It is believed to be the only piece of furniture of its kind in the U. S. An antique collector at San Diego, California, is negotiating for the purchase of one similar which she found in Quebec, Canada. In addition to the oddity of this combination settee-dining table is the fact that it was manufactured near Barbury Cross, England and was brought to San Francisco via Cape Horn, S. A. in 1850. The owner at that time opened the first brewery in San Francisco. It was very old when he gained possession. The exact date of manufacture is unknown.

A Lincoln period settee and four chairs, two large arm chairs and two what now would be called occasional chairs, of solid black walnut is another set of which the Rices are very proud. This was originally upholstered in horse hair, but has been re-upholstered in brocade velour.

Other black walnut pieces are: a turned legged, dropleaf extension dining table; a spool chair with large madelon seat and back, dates back to 1803. Similar in shape, also of walnut, is a Queen Anne chair. This is a very fragile piece of furniture.

Another very useful article is a walnut sewing table of the Lincoln Period, having drop leaves and a drawer.

An especially comfortable, as well as ornamental chair is one belonging to the Louis XIV period, made of genuine rose wood. The high oval back has exquisite hand carvings, has arms and "Queen Anne" front legs. There is no finish other than the beautiful "grain" of the wood, rubbed and polished, used on the very valuable piece. This chair is upholstered in black ground with old rose flowers with green leaves, a genuine antique piece of tapestry.

A wall "whatnot," solid black walnut, elaborately hand carved has a solid shelf at the bottom, two separate round shelves higher up and one round one at the top. The hangers at the sides made in "links" three of each, is carved from one piece of wood. Its age is also unknown. There are also some small corner brackets.

In the curio line excluding furniture, can be found many antiques of various kinds. Among these most treasured is an old cap and ball pistol that Mr. Rice's father gave him. It is exactly like the one Booth used to assassinate Lincoln, if not the very gun. Mr. Rice's mother had among her first housekeeping equipment a wooden potato masher. This was in 1857 and he has it today.

In addition to these, is a heavy crockery ware tea set, comprising of three pieces teapot sugar bowl and creamer. A tiny china shoe with love

La Grande emerged winner of the Eastern Oregon basketball tournament for the fifth consecutive year by winning the deciding game with Baker Monday night, 20 to 23. But the team from the Blue Mountain city won from Baker Saturday night, 31 to 28, making one loss each for the two teams and forcing the deciding game over to Monday night, which was also won by La Grande, this time by a 20 to 22 score.

CALL FOR MORE CCC ENROLLMENT

Young men will have another opportunity to enroll for CCC service, the enrollment period to start around the first of the month, the exact date to be set later. Malheur county will have a quota to fill, and all qualified and interested should apply at the county relief office in Vale on any Wednesday or on Saturday mornings.

Requirements have been liberalized and under the present set up the enrollee need not necessarily be from a family on relief, but must be eligible for relief. Under the present rules, a man who has previously been in the CCC and was honorably discharged, may re-enroll provided it has been a year since his discharge.

When a man enrolls he is expected to stay in camp at least six months. Otherwise he causes the Government excessive expenditure for clothing, transportation, and other items, and does not fulfill his part of the enrollment agreement. In case some extraordinary circumstance arises, or if a man receives an offer of permanent employment, he may be released before the end of his six months term.
