

AN INVESTMENT FOR THE FUTURE

N the news columns of today's Journal is a story about the Reclamation department giving farmers on the Owyhee and Black Canyon projects some 75,000 trees.

This is indeed an investment for the future for our farmers, for on almost every farm, whether it is just reclaimed from the desert or for many years in crops, there is some small area which can be best utlized for a woodlot or shelter belt. These trees, black locust and black walnut lend themselves admirably to our irrigated lands. They require very little care, except for the first two years or so, this fact should not however, tempt farmers to neglect them.

These young trees, in a few years should be large enough for fence posts, and if properly cared for, should provide good fuel, care being taken that when this "deforestation" takes place that the grove is thinned rather than subjected to indiscriminate cutting.

Aside from the utilitarian value of the trees there is the esthetic part that they will take in beautifying our farm communities. And perhaps is would not be expecting too much if our city council would take advantage of this offer (if agreeable to the department) and make use of these trees. The city has available space around the city hall and the ground located in the southwest part of the city, which can only be used for a recreational center, would be an ideal place to plant enough trees to make the starting of a city park.

The Reclamation department is to be congratulated upon it's foresight in making available these trees to our industrious farmers.


