ANOTHER PROGRAM NEARS ITS GOAL

Another "program" of the Nyssa Journal
is nearing its goal. We refer to a market-
ing association for our county farmers.
News dispatches within the last week carry
the information that the agricultural committee
of the Senate has reported favorably on a bill
to assist state departments of agriculture in the
promotion of farm marketing activities.

To assist the states, \$5,000,000 will be fur-
nished from the federal government for the pur-
pose, the various state governments would not
be required to match or contribute. The dis-
tribution is to be based on total population, pop-
ulation on farms and need of the service.

This is a step in the right direction, for what
good will it do to use federal funds to increase
farm production and then not do anything about
marketing it.

These marketing associations work to the
benefit of the consumer as much as it does the
farmer, by providing a steady flow of standard-
ized commodities to the markets. To the farmer
it will provide an economical means of distribu-
tion for his product, which economy will be
passed on to the consumer.

The farmers throughout the county should
make it a point to let the state department of
agriculture know their sentiments on the pro-
posed marketing bill. Our Senators and Con-
gressmen should likewise be apprised of the
importance of this measure.

BEATING THE BREAD LINE

EVEN in these days when we're used to
astronomic figures, \$532,000,000 is a lot of
money. That is the amount of new, ordinary
life insurance sold in the single month of May.

It means that several thousand Americans
have purchased half a billion dollars additional
protection, to be paid them in the future when

workers.

"A LIVING price for milk can be maintained
only through producer co-operation and
vigilance," observes the Dairymen's League
News of New York.

at the mercy of middlemen and others whose
principal interest is in grinding prices down to

markets, better and fairer prices—a living price.

GIVE HIM A BIKE—BUT TEACH
HIM THE RULES

At this time of the year many
parents are saying: "My boy wants
to ride a bicycle—how can I be sure
he will be a safe rider?"

A little training will increase the
pleasure of bicycling as well as the
safety of young people who need to
learn a better way of doing what
they will probably do anyway, ad-
vises the National Conservation
Bureau. Before he is allowed to
take long trips the youngster should
be able to demonstrate, first, a
knowledge of the bicycle as a ma-
chine, second, a knowledge and ob-
servance of all rules applying to

bicycles, and, third, a fairly high
skill in handling the wheel.

Among the things he should be
able to do are: ride slowly for 75
feet in a straight line; ride around
a circle from curb to curb in a fair-
ly narrow street, first in clockwise
direction steering with the left

hand then in counter-clockwise di-
recting steering with the right hand;
demonstrate the correct method of
"anking," demounting and quick
"stopping" with skidding. — Parma
Review.

IN AT THE KILL

The United States senate has
been characterized for years as the
greatest deliberative body in the
world. Another characteristic is
that, once aroused, it is also the
most hostile parliamentary group
toward a leader in whom the senate
loses faith.

In our short period of observation,
we have seen three presidents ham-
strung by the senate, and finally
pulled down to political helples-
ness. It was the senate that, led by
Borah and Johnson, cut Woodrow

Wilson down from a world figure to
a physical wreck. Again it was
largely the senate which made Her-
bert Hoover seem a helpless victim

of unfavorable circumstances, and
now the senate is turning on Pres-
ident Roosevelt in a similar man-
ner. The attack against his moner-
tary bill which brought out Monday

of this week the strange alliance
of Vandenberg and Bridges with
such men as Pittman and Ashurst

is really nothing new in the senate.
They are cutting in now to stop for
all time, a chance that the presi-
dent might seek a third term. Other

reasons may be given as the imme-
diate cause of their groupings, but
the history of the senate is too
plainly written to leave any doubt

as to the real intent. By reducing
presidential prestige now, they will
not have to overcome it in the cam-
paign of 1940.

This is one of the peculiar fea-
tures of the American government,
and, without disrespect to anyone,
probably as effective a means as
any in preventing the one thing
which Americans fear greater than
all else—a system of political suc-
cession that does not depend on the
free choice of the people. It is a
lifesaver as applied to the republic
a man-killer as applied to the presi-
dent. The senate from now until
election time as year from this fall
will be outrunning each other to get
in at the kill.—Wendell Irrigation-
ist.
