WE STILL ASK— WILL THEY BENEFIT?
THE following is a letter from Congressman
Pierce, which we are glad to publish here
as a part of this editorial—there are a few points
that the Congressman takes a bit too literally
—but we will go into that after you have read
his letter:

"I have just read your editorial under date of
January 4 entitled WILL OUR FARMERS
BENEFIT? I want to congratulate you on this
editorial—it is well-written; it states your case
clearly, and shows you are thinking, which is
all-important in this government of ours. As you
undoubtedly know, I have not been with my
party on the reciprocal trade agreements. I
have said so plainly by my vote and spoken
words in the House.

"I note in your editorial that you want to be
represented, I presume in both the House and
Senate, 'by persons in Congress who will get in
on the floor of the two Houses and battle to the
bitter end for our farmers.' My experience here
through the many sessions of the past seven
years has confirmed my early belief that effective
legislation is seldom brought about by the
loud, vociferous speakers, but rather by the
quiet, yes, compromising effort in committee
and with groups. It seems to me that the farm-
ers, during the present Administration, have
been quite effectively represented in committees
and on the floor of the Senate and House. I re-
present our whole western country on the House
Agricultural Committee where I have been at-
tentive and active.

"Remember this, my dear Editor, the great in-
dustrial East really wants cheap food—they
work in factories; they want to buy that cheap
food and they don't care where it comes from as
long as it is good and cheap. It has been said
many times that since the war between the States
this Government has been largely controlled by
the banker group of the Atlantic border. Oh, yes,
we have had concessions, many of them—but
they have been won often times by good political
trading. We farmers want cheap interest
rates; the Congressmen are not all interested in
low interest. We want cheaper transportation;
many of the Representatives are not interested
therein. It is not 'whining' to state facts.

Just think: March, 1933—the whole agricul-
tural world in America was bankrupt from end
to end. Wheat was 20-cents a bushel in Malheur
County. We have doubled and tripled the price
of wheat to the people of the Pacific Northwest
by legislative acts, and they haven't been gifts
handed out by the controlling East. I, myself,
sold good beef cows at a cent-and-a-half per
pound in the Grande Ronde Valley. They are
much higher now. Wool, I remember when it
was sold at eight-cents in 1932. This Adminis-
tration offered to lend sixteen-cents on it. That
fixed a minimum price. Even butterfat has been
materially helped, though less than some other
lines.

"I myself raised sugar beets several years at
a heavy financial loss. You now have a sugar
beet factory, and by compromise legislation, by
subsidy and bonus, we are able to get to your
sugar beet raisers more than \$6.00-a-ton aver-
age for beets. And we have done that without
raising the price of sugar to the consumer. Last
year in the Nyssa sugar district, you got one-
sixth of all the extra acres that could be planted
to beets—think of it—and all the sugar fac-
tories in the United States, and yours a new fac-
tory. That didn't come to the Nyssa sugar beet
farmers out of a clear sky. That was the result
of work and co-operation. Right now, I am
struggling to remove all acreage quota control
on sugar beets for the Nyssa district. Of course,
you know, that the domestic quotas are not fix-

ed by the Congress but they are determined in
an office in the Department of Agriculture.
"Nearly three-quarters-of-a-million dollars
have been taken from the treasury of the United
States and loaned, under the Farm Security Ad-
ministration, in Malheur County alone trying to
rehabilitate farmers who have fallen by the way-
side. We all know there will be losses in that,
but it has certainly helped, not only farmers,
but businessmen, as well, and your whole com-
munity. We have a long way to go yet, many
things to be accomplished, but just give us cred-
it for trying, and still keeping up the fight. All
I am asking is that you give us credit for doing
some things, and for our attempt to do more.

To begin with we believe that Mr. Pierce is
to be congratulated on his stand, even against
his own party, against the so-called "reciprocal"
trade agreements.

However, in going over the editorial men-
tioned, we cannot see in it any mention of "loud
and vociferous speakers." As to effective repre-
sentation, there are two sides to that question,
we have only to look at our sugar situation to see
in one case where that effectiveness was "out for
a walk". And it is upon this point also that the
farmers are in need of "fighting" representa-
tion. If the eastern pressure groups want cheap
food, and sugar in particular, do they not at the
same time want protection against the impor-
tation of foreign farm implements so that they
can get a higher wage through higher prices on
those farm implements? At this point may it
not stand the western representatives in good
stead to hammer down, or at least oppose high
tariffs on the implements that our farmers buy
to raise the "cheap" foods that these easterners
want?

Times have not changed since Mr. Pierce
raised sugar beets—for any sugar beet grower
will be quick to inform you that there is no
money in \$6 beets—and this year the growers
in the Nyssa district will receive around \$5.94,
less a small charge for county "administration"
of the sugar act.

On this point of raising the price of sugar to
the consumer—the average per capita consump-
tion of sugar in the United States is somewhere
around 103 pounds. On this basis if the grower
was assured an increase of \$1 per ton more
for his beets, with a sugar content of around 16
per cent, it would cost the consumer less than
three packages of cigarettes or a manicure per
year! So the consumer need have little fear of
our farmers running them to the poor house
when they ask for protection against foreign
peon labor raised sugar.

As to the Farm Security Administration loans
to our farmers—we have no less an authority
than W. N. Young, county supervisor, who made
the statement about two months ago, that up to
that time there had been no losses to the FSA
on loans made in this county—truly a tribute to
those who found themselves in need of a loan.
And our businessmen too, deserve some of the
credit for the success of our farmers in their en-
deavor to make their farms pay—for the busi-
nessman has also extended credit to our farm-
ers in order that they may be carried over the
rough spots.

And again may we say that our hat is off to
Congressman Pierce for his stand against these
cock-eyed trade agreements—at least take it out
of the hands of one man (the sugar act, too,
for that matter) and put it up to the congress, as
to whether or not our farmers are getting a
square deal when it comes to our international
"horse-trading"—for no man who has been
raised in the east can feel sympathetic to a farm-
er who is asking only for a fair price for the re-
sults of his year's work.
