**Committee Reviews Needs of Youth**

(Editor's note: This is the third of a series of feature articles by Ann Sullivan on the newly released report of the Governor's Committee on Children and Youth, following two years of work and study by hundreds of people throughout the state of Oregon.)

If a small child's personality is to develop with the greatest chance for emotional health, he must be cared for in a family home with one mother, either his own or a foster one.

"Oregon should move away from continuing institutional programs for infants and pre-school children, except where medical or other health reasons indicate institutional care is needed."

Such is one of a number of conclusions discussed in a section on child welfare in the recently released report of the Governor's Committee on Children and Youth.

The committee also makes specific recommendations in the field of adoption and the need for strengthening adoption laws; for homemaker services; and for day care services for children of working mothers.

Because of the current widespread attention and criticisms of Aid to Dependent Children programs, some of which is deployed by the committee, their recommendations in that field will be reported in a successive article.

On the institutionalization of small children, the report notes that research findings and informed opinion of medical authorities, both in child psychiatry and pediatrics, strongly point to the need for small children to be cared for in family homes if the child's personality is to develop with the greatest chance for his best emotional health.

The U. S. Children's Bureau and literature in the child welfare field strongly support the principle that pre-school children should not be cared for in institutions because they cannot get the same individual care, attention and affection they could from a

parent, whether their own or foster.

The committee said that to accomplish the objective of taking these small children from institutions, there must be adequate programs and services to support them, including casework service for families in their own homes, homemaker services, adoption services and the development of foster home programs.

The report describes its recommended homemaker service as that in which "a mature, specially trained woman, with skills in homemaking and in establishing health relationships with people, is placed by a public or private health or welfare agency in a home where her services are needed to maintain it as a unit."

Such services are designed to provide care on a temporary basis to children and families when the mother is absent from home for illness or for other reasons. There is no service yet established in Oregon, although a number of other states do have it. Plans exist for its establishment in Multnomah county.

Oregon adoption statutes permit indiscriminate placement of children in adoption, the committee found, with the result that adequate safeguards to children, natural parents, adoptive parents and communities are not achieved.

"New legislation is necessary," the report states, pointing out that it can be accomplished only through a cooperative effort of the medical, legal, ecclesiastical and social work professions with the help of broadly representative community groups interested in the welfare of children.

Eight pages alone are devoted to the need for increased day-care services for children of working mothers or in other cases where parents for one reason or another are unable to assume the normal parental responsibility for full-time care.

The report notes that one in four working women in Oregon supports one or more dependents, most often on a low salary.

The committee recommends in all parts of the state there be an adequate number of places where children may receive acceptable care outside of their own homes while their mothers are working and the need for improved state standards of licensing such.

The need is great for more community-supported day-care programs, the report states, particularly in cities such as Eugene, Salem and Corvallis.

Recommendations in related services include the need to provide more training opportunities for adults working with children and the need for higher salaries to attract and hold more professionally trained people in the field.

More education of the public in the need and better community understanding and effort are also sought.

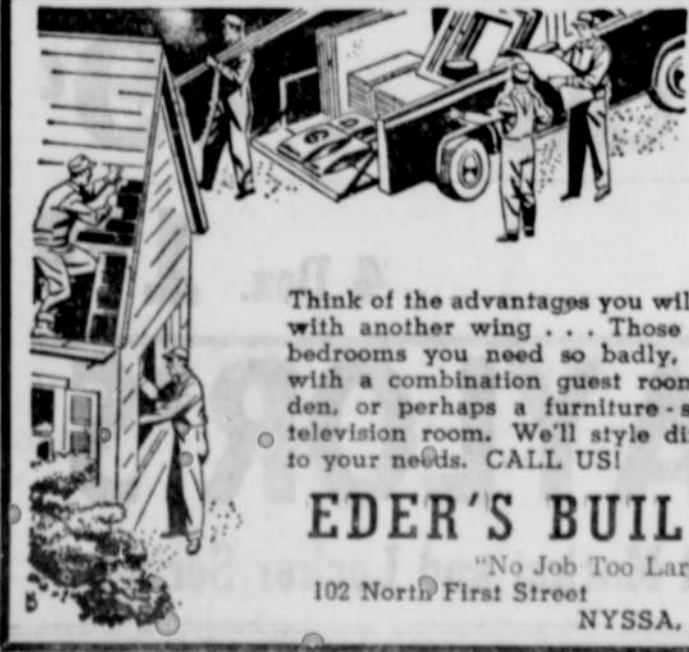
