In Gilroy, California

Lester C. Lankford, 48, died suddenly on Saturday, April 30, only a few days after moving into a home he and his wife had recently acquired.

He was the husband of Mrs. Pauline Lankford, a bookkeeper at Wells Fargo-American Trust company and was the father of Lynlee Lankford and Dale Lester Lankford, all of Gilroy, Calif. Lankford, a native of Ft. Collins, Colo., had lived in Gilroy for three years. For a time he worked as a civil engineer for W. J. Hanna & Son, and in recent months had been connected with a San Jose firm. He and his family went to Gilroy from Nyssa.

Survivors, besides his wife and children, are his mother, Mrs. Ethel Gaines of Caldwell, Idaho; two brothers, Sam Lankford of Nyssa and Donald Lankford of The Dalles, Ore. He was the brother of the late Nancy Gannon.

Drunken Driving
Gets More Study
By Lawmakers

Traffic safety as it applies to proposed legislation will be a principal topic discussed at statewide hearings to be held by the Highway Interim committee the week of May 23-26, Senator Anthony Yturri, Ontario, chairman, announced this week. Other items on the agenda include parks, gas tax refund and transportation permits.

A specific item under the general heading of traffic safety is drunken driving legislation which has been under study for the past several months. One proposal studied is the enactment of a law which would require implied consent to submit to a chemical test and in effect would require persons arrested of drunken driving to submit to a chemical test to determine the extent of alcohol content in the blood.

Refusal to submit to such a test would result in revocation of driver's license and would be admissible in evidence if a court trial resulted. The other proposal would grant to an enforcement officer the power to make an arrest for "driving while under the influence of intoxicating liquor" upon probable cause without a warrant.

The interim committee is anxious to get public reaction to these proposals which will probably come before the legislature at the next session, Sen. Yturri said, and invites testimony from anyone interested.

J. I. Brady Succumbs
In Boise Hospital
After Heart Attack

James I. Brady passed away Saturday, May 14, at the Veterans' hospital in Boise after suffering a heart attack early that morning.

Mr. Brady was born December 5, 1889 near Wabunsee, Kansas and grew up in Kansas and Colorado. He was graduated from Kansas State College in 1918 as a mechanical engineer and immediately enlisted in the U. S. Navy. He served overseas and was promoted to warrant officer and commissioned an ensign prior to his return to civilian life in 1919. He was then employed by Black & Veatch of Kansas City as a resident engineer.

Mr. Brady married Elsie Loretta Baird March 7, 1920 at Cherryville, Kansas. They established their home at Wellington, Kansas where he operated his own machine shop until 1936. At that time, he moved the shop to Ontario, Oregon and home-stayed the present Brady farm near Nyssa. After his sons entered the service during World War II, he made farming his full time occupation until his death.

Mr. Brady is survived by his wife, Elsie; two sons, CWO Roy Brady of Glasgow Air Force Base, Montana and Gene of Meridian, Idaho; a daughter, Mrs. Ann Clarkson of Portland, Oregon; one brother, three sisters, and thirteen grandchildren.

He was a Scottish Rite Mason, attaining the thirty-second degree, a member of the American Legion, and a member of the Methodist church.

Reverend Bruce Tharrington officiated at the memorial services held at Lienkaemper Chapel Tuesday afternoon, May 17. Graveside services at the Nyssa cemetery were held by the Golden Rule Lodge No. 147, A. F. & A. M.
