Motion made to issue a deed to Cyril B. and Luzetta B. Fuhrman for one acre, more or less, located South of Malheur River, Northwest of Southeast, Northeast of Southeast, Section 20, Township 18, Range 45, to correct a deed issued to them in 1954 in which this parcel was omitted.
