R. Smith Summarizes Legislative Activities

 deficit with the needs of additional funds for the education of children, the extension of highway assistance and the problems in welfare. Because of political timidity and the memories of 1955, when the Republicans were replaced in the Legislature because of a surtax, the Democratic majority argued and belabored methods to raise this additional money without enraging the taxpayer.

Controversial Issues Follow

Later followed such controversial issues as the important three-way bill, which finally failed, allowing private enterprise to write insurance in the compensation field, which is now controlled by government monopoly. This bill, which passed the Senate, increased for the first time since 1957 compensation rates for injured workmen. The House leadership failed to acknowledge the needs of the workmen and denied opportunity for the passage of this bill.

The waning days and hours of the session found such controversial issues as Senate Bill 406, the agricultural picketing bill, so important to farmers growing perishable crops such as pears, cherries, strawberries, apples, sugar beets, etc. After four motions were defeated for suspension of the rules to consider Senate Bill 406, finally I was successful in bringing to the House for final vote and ultimate passage this important piece of legislation to Malheur county and to the farm-ers of the state of Oregon.

The final hours of the session were filled with House resentment toward the Senate over a dispute arising over transferring tuberculosis patients from Portland to Salem and the amount of increase which should be given to employees of higher education, civil service employees and other elected officials.

E. Oregon Solons Cooperate

On a bright note, Eastern Oregon, in my opinion, fared exceptionally well during the session. As a result of the elimination by reapportionment of five members of the delegation, we seemed to be a closer working, unified group. Senator Yturri and I worked closely together on problems affecting our area and complemented each other's actions in the House and the Senate. We conferred many times throughout the session and assisted in the passage of several bills which were of vital importance to our area.

Some of these bills included subjects of land management, fire protection, temporary certificates for hospitals and nursing homes with regard to fire precautions, a request to Congress for increasing tenure on Bureau of Land management permits and many others too numerous to mention.

Governor Vetoes Land Bill

My one disappointment was the governor's veto of House Bill 1551, which would protect counties from the federal government arbitrarily taking lands from the county tax base and adding them to their wildlife refuges. The bill would have allowed counties to sit down with the federal representatives and arrive at terms to replenish the treasury of the counties on lands taken off the tax rolls because of federal purchase.

The governor vetoed the bill because he felt this was a statewide problem rather than a county problem. In doing so, however, he promised in his veto message to protect the erosion of the tax base within the counties. I will continually remind him of this promise as the federal government proceeds in their purchases within the affected counties.

Session Ends With Resentment

Final adjournment came on a note of House resentment against the Senate and mingled feelings of dissension between House members. I concurred with the Senate on all counts in these last hours because they arrived at a logical solution to the tuberculosis patient problem, saving meanwhile \$600,000 for the state.

The Senate also stood fast but lost an attempt to curtail higher education salaries and civil service salaries to a reasonable increase of 4 percent, rather than the additional \$2 million which a majority of the House finally passed.

I continually fought and lost the battle to curtail the spend-thrift nature of this session. I opposed the tax program, which I felt was excessive on the one hand and poorly devised on the other. I supported the cigarette tax because here was a tax, in my opinion, which could be avoided should the people feel an excessive burden.

Sees Complete Tax Revision

I will continue to feel and believe, after income taxes are raised by an average 24 percent, that the taxpayers will look for methods such as the cigarette tax

and possibly a sales tax, exempting food, drugs, other necessities of life, which will offset property tax and income tax, to be the final answer for a complete tax revision in the state of Oregon.

Area Hospitals Plan Program Participation

 standings between hospitals and patients results from the feeling that "room rate" is a yardstick by which the total bill may be measured," he said.

Actually, however, the hospital bill is a combination of room rate and special services ordered by the physician for his patient — services which may amount to as much or more than the total room charge.

Hospitals which have adopted the "guiding principles" will abandon the term "room rate" in favor of the term "daily hospital service," with the new term to include all commonly used services and supplies provided in relatively equal quantities to each patient.

The DHS charge will be based on the patient's pro rata share of the total cost of hospital operation including proportionate overhead costs. Adoption of the "guiding principles" is not expected to increase the cost of hospitalization to patients, but will simplify and clarify billing procedures.

Hospital objectives, as outlined in the principles, emphasize that "financial return and other interests are secondary" to the hospital's first obligation to furnish care to the sick and injured. Other hospital objectives include advancing scientific knowledge, furthering employee education and promoting community health.

In addition to general safeguards concerning the quality of service and protection given the patient, the code restricts duplication of facilities in other community hospitals when such duplication would increase care cost.

Hospitals are charged with admitting persons regardless of race, creed or color. The statement emphasizes that an acutely ill patient will not be subjected to delay in receiving emergency care and that emergency patients will be given first aid immediately regardless of financial status.

The OAH has also written a self-policing provision into its statement with establishment of a "Committee on Guiding Principles" which will work to maintain those principles.

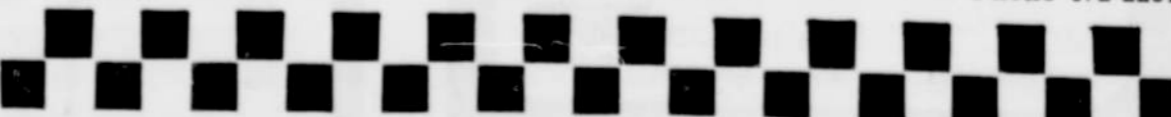
