CIVIL RIGHTS CONTROVERSY

The squabble over the civil rights bill in Washington should cause every American to take a second look at his heritage. In the first place, such a bill should not be necessary. Our Constitution and Bill of Rights is a first-class civil rights bill.

The current civil rights bill has been described as a law to supplant property rights with human rights. There are many who are sure the bill will suppress one group in order to grant rights to another.

The bill is deeply complicated and the charge of power-seeking by the federal government is but one of the many complaints against the proposed legislation.

The most bothersome aspect of the situation is the complete disregard for rights of others, displayed by those who seek more rights for themselves. Unlawful gatherings of mobs who demonstrate by destroying personal property—blocking entrances to business places—and outright riots seem to be the tools of those who seek to improve their own rights and status in the community.

Whether a law will change the standing of any citizen is questionable. We are a nation of status seekers and status seeking is just as prevalent among races as it is in the population at large.

To force an employer to hire someone he does not want working for him is an invasion of his right of free choice. To deny right of access to a restaurant or a hotel is an affront to the denied. Which right should be protected? Will a law help?

Does the flaunting of the law by race demonstrations improve the chances of equal rights for all? If such actions are the right of the citizen and if police are

IT'S YOUR LAW

LEGAL RESPONSIBILITIES IN FORMING CORPORATION

Johnny was a promoter who had saved up a nest egg of \$20,000 and wanted to make a "big deal."

He planned to form a corporation and get financing to buy land for a shopping center. He found a location he liked and signed an earnest money contract to buy it, paying \$5000 down and agreeing to pay the balance on closing 90 days later by forming a corporation and getting a loan.

He signed the earnest money agreement. "John Jones, as agent for a corporation to be formed." The agreement provided that the purchaser would immediately apply for a loan on the land.

The next day Johnny changed his mind and decided not to go through with the deal. His wife said, "Aren't you afraid you're going to lose your \$5000 down and maybe more?"

Johnny replied, "That contract isn't binding. I signed as agent for a corporation to be formed. If I don't form the corporation, there's no one to be bound by the contract."

Do you think Johnny is right? Unfortunately for him, he is not. An agent who purports to sign for a principal who doesn't exist and who the other party knows doesn't exist, may bind himself.

In such a case the rule is that the parties intended to bind someone and since the agent is the only one who could be bound by such a contract, the courts hold that it was the intention of the parties to hold him to the contract, as an individual.

Johnny discovered, to his dismay, that the contract was binding on him, whether or not he formed a corporation.

(Oregon lawyers offer this column as a public service. No person should apply or interpret any law without the aid of an attorney, who is completely advised of the facts involved. Even a slight variance in facts may change the application of the law.)

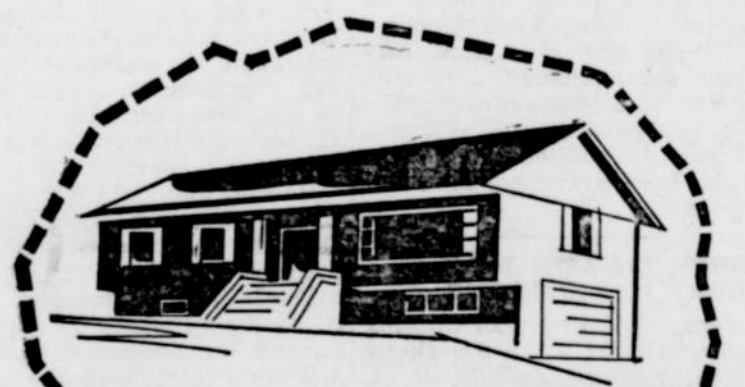
