PROCLAMATION WHEREAS, at a special election held in the City of Nyssa on the 29th day of June, 1965, there was submitted to the legal voters of said City of Nyssa the proposition of adoption of a proposed amendment to the Charter of the City of Nyssa by adding thereto a new chapter authorizing the Common Council of said City of Nyssa to construct a supplemental water and distribution system in addition to the present system, including the sinking of wells, installation of pumps, pipelines and other equipment and the acquisition of the necessary sites, easements and rights of way therefor; to issue and sell General Obligation Bonds of the City not exceeding \$120,000.00 to provide funds therefor; to pledge net revenues of the water system and to provide a tax levy to pay the principal and interest of said bonds; and

WHEREAS, the returns of said special election have been duly filed with the City Recorder and have been duly canvassed and examined by the Common Council of the City of Nyssa; and

WHEREAS, it appears that a total of 89 ballots were cast at said special election on said proposition, and that 79 ballots were cast in favor of the proposition and were marked "560 x Yes," that 10 ballots were cast against the proposition and were marked "501 x No," and that a majority of said votes cast were cast in favor of the adoption of said amendment to the Charter of the City of Nyssa.

NOW, THEREFORE, I, Grant H. Rinehart, mayor of the City of Nyssa, do hereby proclaim that the proposed amendment to the Charter of the City of Nyssa, as submitted to the legal voters of the City of Nyssa, pursuant to Resolution No. 258 adopted the 8th day of June, 1965, has been approved by the legal voters of the City of Nyssa and does become effective as of the close of said election on the said 29th day of June, 1965.
