Methodists Burn Mortgage Sunday During Dedication Rites at Church

"Some were skeptical when we set out to erect the new educational building," said the Rev. Paul L. Ludlow Sunday, Oct. 3, during mortgage-burning ceremonies at Nyssa Methodist church, "but aren't we glad now that we went ahead with it, for now a fine unit is complete and free of debt."

The Rev. Ludlow, former Nyssa pastor, now of Burley, Idaho, was guest speaker for the occasion marking more than six decades of service to Nyssa and the cancellation of debt on the educational wing of the church built in 1956-57. A ceremony, in which a photo-copy of the mortgage was burned, was a highlight of the program, and a fellowship dinner was served following the morning service.

Cliff Main, builder of the church unit and present chairman of the official board; Don Oldemeyer, church treasurer; the Rev. Ludlow and the Rev. Ralph A. Lawrence joined in burning the mortgage.

It used to be that when you wanted something, you worked to earn it. Now you stage a riot to get it given to you at someone else's expense.

If your father or grandfather lost his job, he took whatever work he could get, and he went (probably walked miles) to where there was work—any honest work—being done. Now hordes of relief "clients" refuse a job unless it is to their liking, and they demand the job be brought to them in their community.

This nation was built by immigrants (beginning in the 1600's and earlier) who struggled here for opportunity, and would have scorned the false idea of "something for nothing." Now it seems to be an almost universal (and all-too-often the only) ambition.

Son of Nyssa Couple Electrocuted On Idaho Farm; LDS Services Held

Funeral services for Alvin R. McDermott were conducted Tuesday morning, Oct. 5, 1965, at Peckham-Dakan-Davis chapel in Caldwell, with Bishop Marvin E. Channer of the Marsing LDS church officiating.

The body of the 40-year-old electrocuted farmer, a son of Mr. and Mrs. Lawrence Charles McDermott of route 1, Nyssa, was found Friday lying near the foot of a power pole on his farm in the Opaline community, about eight miles southeast of Marsing, Idaho.

Owyhee County Sheriff Al Barberis reported that he also found a tractor and attached elevated manure loader standing nearby.

According to the sheriff's report, power to the McDermott farm had been cut off by direction of the power company. Barberis said he discovered a nylon rope extending from the transformer on the pole to the main powerline.

The officer reported that he also discovered that two bolts on the transformer had been removed or loosened and that burned areas on the pole indicated that a short circuit had occurred.

Mr. McDermott was born July 9, 1925, at St. Francis, Kan., and at six years of age, moved with his parents to Colorado. They came to the Nyssa area in 1936 and the deceased attended schools

in Adrian and Nampa. During World War II, he served in the U. S. Navy.

He was married to Chrisella Ruth Tullis on Jan. 7, 1945, in Nampa where they resided for some time before homesteading in Wyoming where they lived for four years. After residing in Arizona for a short time, they moved in 1956 to the present home.

The deceased was an active member of the Marsing LDS church and coach of its softball team.

In addition to his parents of Nyssa and his widow of the home, he is survived by two sons, Terral K. who was recently called to serve an LDS mission in the central states and Darren of the home; three daughters, Kathleen, Shannon and Lanette, all at home.

Other survivors include four brothers, Charles of Salt Lake City, John of Meridian, Idaho, Larry of Pilot Rock, Ore., and Bud of Moses Lake, Wash.

Also surviving are six sisters, Mrs. Alla Province of Caldwell, Mrs. Beulah Voss of Sunnyside, Wash., Mrs. Velma Derrick of Williams Lake, B. C., Mrs. Ruby Bailey of Coos Bay, Ore., Mrs. Nellie Eason of Parma and Mrs. Verla Baxter of Kennewick, Wash.

Burial was made in Kohlerlawn cemetery at Nampa. Active pallbearers were Keith Johnson, Blanton McLaurin; Clinton, Edwin, Duane and Marlin Tullis.

Honorary bearers were Bill Baxter, Elmer Derrick, Ralph Bailey, Neil Sweet and the four brothers of the deceased.
