

Woman Killed in Friday Accident; Others Escape Serious Injuries

Augustine (Herminia Herlinda) Lumberas was killed Friday afternoon when the car in which she was riding struck a telephone pole after colliding with a vehicle driven by Mrs. Maxine Stringer. The accident occurred at the intersection of North Fourth street and Ehrgood avenue.

Vickie Byrd, 37, driver of the auto in which Mrs. Lumberas was a passenger, was uninjured. The 11-year-old daughter, Mrs. Byrd, and Mrs. Stringer were taken by ambulance to the Memorial hospital where Mrs. Lumberas was hospitalized. Valdemar, a three-year-old son of Mrs. Lumberas, was given emergency treatment and released, unharmed.

Homeowner Notifies Police

The car was damaged extensively and there was minor damage to the house. No one was in the dwelling when the accident occurred; however, Lewis told a Journal reporter that he was on his way home, saw the car crossing his lawn, hurried to the scene and notified authorities.

Chief Allen said no citations were issued as it is an open intersection and no skid marks were visible. "It seems to be a case of neither driver seeing the other car," he added.

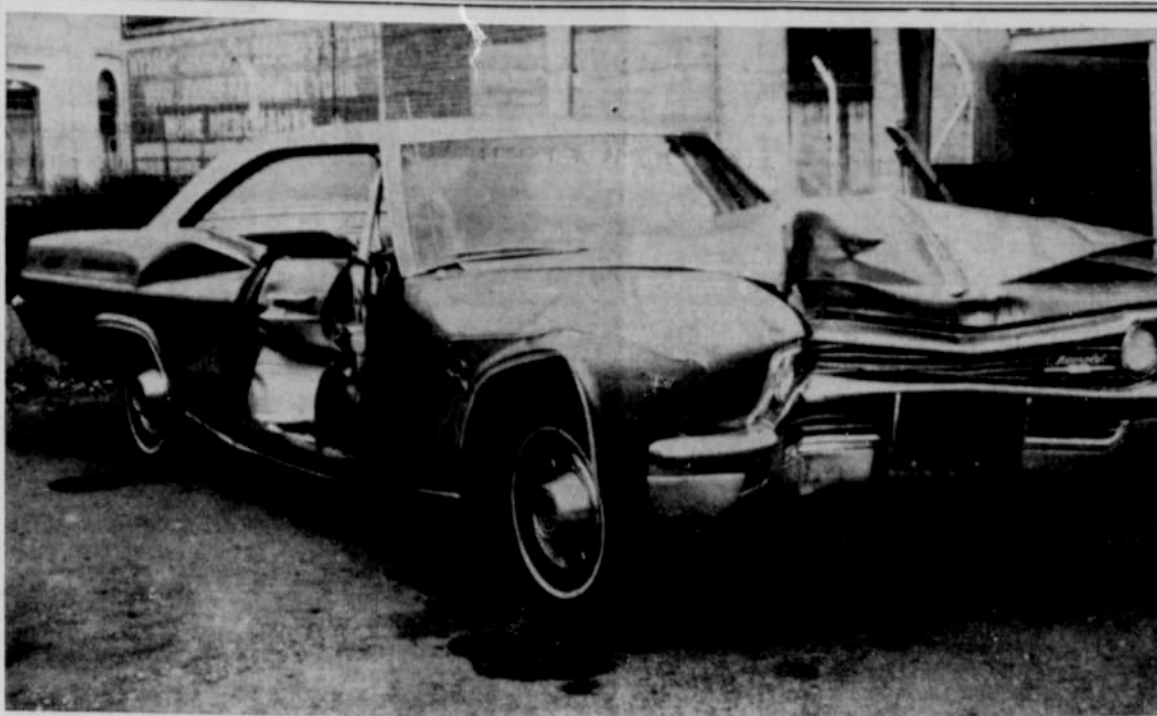

Downward Slump In Oregon Milk Production Slows

Oregon's long downward skid in milk production began to slow in September when the state's dairymen marketed more milk than the same month last year.

Stephen Marks, Oregon State university extension agricultural economist, said late summer rains apparently improved dairy pastures enough to stop the sag in milk output. Production was up four percent above the 78 million pounds tallied in 1965, which was the lowest production on record.

Pasture conditions at the start of October showed improvement over September, according to Marks, but were still rated one point less than a year earlier and 12 points below average.

Wholesale Prices Increase

Milk prices moved higher in Oregon to an average of \$5.35 per 100 pounds of wholesale milk. Marks said this is up 20 cents from August and 80 cents above September 1965.

"It looks as if the 1966 average will be the highest since the 1953 figure of \$5.28," he said. "Record highs occurred in 1951 and 1952 during the height of the Korean conflict."

Dairy feed costs are also higher this year because of the smaller overall supply of grains and hay, according to Marks, but increases are less than the advance in milk prices. The milk-feeder price ratio is at the most favorable level in many years, he added.

Local Chapel Rites To Be Held Friday For Willie McGinnis

Funeral services for Willie McGinnis, a 50-year resident of the Nyssa area, will be conducted at 2 o'clock Friday afternoon, Oct. 28, 1966, at Lienkaemper chapel. Officiating minister will be the Rev. Jack Jamison of Nyssa Church of the Nazarene.

Mr. McGinnis succumbed early Wednesday morning at Malheur Memorial hospital where he had been a patient for two weeks.

He was born Nov. 14, 1893, at Susanville, Calif., a son of James P. and Jane Cantrall McGinnis. The deceased moved to the Nyssa area in 1916 and on Nov. 9, 1931, he was united in marriage to Edna Griffith at Vale.

Mr. McGinnis worked for the Bureau of Reclamation and North Board of Control until his retirement several years ago.

He was a member of the Nazarene church, American Legion, Disabled Veterans group and a veteran of World War I.

Survivors include his widow of the home at 220 Chestnut avenue; one daughter, Mrs. Darrel (Nellie Mae) Davis of Fruitland; three brothers, Donald of Echo, Ore., Vernon of Tiller, Ore., and Glenn of Nyssa.

Also surviving are five sisters, Mrs. Joe (Geneva) Wistos of Alturas, Calif., Mrs. Howard (Gladys) Conaughy of Vale, Mrs. Henry (Jessie) Slippy, Mrs. Mary Jarvis and Mrs. Don (Virginia) Linville, all of Nyssa; and one grandson.

Mr. McGinnis was preceded in death by his parents and three brothers, Alvin McGinnis, a former resident of the Adrian area; Andrew McGinnis of Nyssa and John McGinnis, who died at a young age.

Interment will be in Owyhee cemetery with concluding services by members of American Legion Post 79 of Nyssa. Lienkaemper chapel is in charge of arrangements.

'Tight Money' Plus Federal Measures Said Cause of Industry Loss in State

The "tight money" situation and federal measures to discourage business expansion probably have cost Oregon six new industries in the past few months, according to S. H. Mallicoat, administrator of the Division of Planning and Development, Oregon Department of Commerce.

Mallicoat said companies which have cited "tight money" policies as the primary reason for postponing or cancelling plans for locating plants in Oregon include two metal firms, a plastic products firm, a rubber products firm, a textile firm and a transportation equipment manufacturer.

Three of the firms were considering locations in eastern Oregon, one in southern Oregon, one in the Willamette valley and one in the lower Columbia area.

Another result of the current situation has been a substantial slow-down in the number of prospective new industries being serviced by the division. Mallicoat said that during the first four months of the year the division was serving an average of 15 industrial prospects a month.

This has dropped to a monthly average of eight during the past four months.
