**OBITUARIES**

**KYLE PACE NIELSEN**  
Funeral services for Kyle Pace Nielsen were conducted Wednesday morning, June 11, 1969 at the Parma ward of the Church of Jesus Christ of Latter-day Saints by Bishop Louis E. Phillips. Interment was made in the Parma cemetery, under direction of Lienkaemper chapel of Nyssa.

The 10-year old son of Mr. and Mrs. Melvin R. Nielsen succumbed Sunday evening of an apparent accidental gunshot wound. According to Canyon County Sheriff Dale Haile, the accident happened near the victim's home in the Apple Valley area.

Officers reported that the lad was fatally wounded in his side when a 12-gauge shotgun held by a hunting companion discharged accidentally. The lads were hunting magpies, an officer said. Kyle was born Jan. 22, 1959 at Nyssa and attended Parma schools.

In addition to his parents he is survived by four brothers, Val, Chad, Rod and Larry of the home; three sisters, Nanci, Margie and Lisa, also at home.

Also surviving are the deceased's grandparents, Mr. and Mrs. H. Lawrence Pace of Apple Valley and Mrs. Alameda Nielsen of Salt Lake City.

**JOHN McCAMISH**  
Services for John Obed McCamish, a resident of Weiser since 1942, were conducted Wednesday morning, June 11, 1969 at North-Jones chapel in Weiser, with Ronald Franklin officiating. Interment followed at Hillcrest cemetery.

Mr. McCamish succumbed Sunday in a Weiser hospital. He was born Nov. 13, 1889 in Fayetteville, Ark., a son of John and Margaret McCamish. He was married in June 1908 to Vera Edmiston in Arkansas. She died in 1931 in South Dakota.

In 1933, Mr. McCamish was married to Hilda Arneson at Custer, S. D., and they moved to Sandpoint in 1941. The following year they moved to the Weiser area where they farmed in the Crystal community. The deceased retired in 1952.

The couple then moved into the city of Weiser where they had since resided. Mr. McCamish was a member of the Jehovah's Witnesses church in that city.

In addition to his widow, he is survived by four sons, Jay C. of Nyssa, Connie of Washougal, Wash., David A. of Mountain Home and Carthol McCamish of Sunnyvale, Calif.; four daughters, Mrs. Bill (Fay) Barton of Seattle, Mrs. John (Joyce) Harmon of Ontario, Mrs. George (Leona) Olds of Sebek, Minn., and Mrs. George (Lucille) Kessick of Kennewick, Wash.

Other survivors include a sister, Mrs. Eugene Scott of Bell Fourche, S.D.; 21 grandchildren and several great-grandchildren.

**CHURCH OFFICIALS ANNOUNCE PLANS FOR CANADA MEET**

Officials at world headquarters of Jehovah's Witnesses have extended an invitation to the entire Payette congregation to attend the international conference scheduled July 13-20 at the Empire stadium in Vancouver, British Columbia.

Delegates from this area will join the 35,000 patrons expected to go to Vancouver from countries around the globe for religious training and direct communication with others of the faith. Most Nyssa families are planning to travel by auto to attend the convention, and no doubt most are including vacation plans in their arrangements.

For the assembly, approximately 7,000 volunteer workers will be needed. To care for the comfort of visitors, twenty different departments have been organized. Among these is the one to provide rooms, and another will prepare and serve over 170,000 meals.

equivalent full-time students, but that they anticipated 950-1025, and in this manner they hoped to take care of part of the deficit.

John Fowler, CPA, who audits the college records, said the college was operating on a current basis and that this was the first year that the board and administration had full control of finances and knew what was in all funds and what had been spent at all times. He affirmed that the only outstanding indebtedness, other than bonds voted by the electorate, was the two months salary bill for July and August in the amount of \$89,000.

**SCHOLARSHIPS**

In answer to a question on scholarships, Saito said the college granted 40 to in-state students, with one half of these going to girls. These, he said, were merit awards based partly on needs, and were not given in any particular department. That athletic scholarships were treated in the same manner as music or any others.

**ATHLETIC PROGRAM**

"How much of taxpayers money is spent for athletic coaches?" "NONE," was President Skinner's reply. He further stated, "Student fees, gate receipts, and concessions take care of the entire program and returns a profit of about \$15,000. This becomes a part of the general funds and may be used for many things."

**CREDIT TRANSFER**

"Why can't credits be transferred from TVCC to other colleges?"

Dean Ed Haynes, told the inquirer that vocation - technical courses are designed for two years completion and that it was true some colleges would not accept these. The same was true, he said, of pre-law, pre-med and architecture.

But, liberal arts college credits, were acceptable to any college or university in the Northwest states.

**OTHER QUESTIONS**

Other questions came on the college renting housing, feeding the students and operation of the dorms. Dean Murray reported the damage to dorms had been exaggerated and that the \$35 deposit required of each student had taken care of all damages.

The food and housing services were self-supporting, he said, and should soon start showing profit.

The effect of a new college in Baker was thought to be minimum by Skinner due to tuition fees of \$900-\$1,000 per student, that it was a specialized school, not accredited, with students drawn from a wide area.

Joe Saito told Jake Fischer he did not know why a TVCC baseball game was played on the Payette diamond instead of Nyssa where some of the taxpayers lived, "but, he replied, it sure won't happen again -- at least not before the next election."

**FACULTY BACKS BOARD**

A resolution backing the board of trustees was read by faculty member Norm Millikan. It follows:

**YOUTH NIGHT**

We, the Treasure Valley Community College Faculty Association, having a genuine concern for the continuing improvement of educational opportunity, believe that:

Since the Business Office procedures are the most orderly and efficient that Treasure Valley Community College has had since its beginning; And since the current budget is a conscientiously and realistically drawn budget, in that each department was consulted as to specific needs and asked to submit minimum requests, nearly all of which were further reduced in the interest of presenting to the public the lowest possible budget;

And since the intent of the present administration and faculty is to work for the betterment of the college as a whole and to develop academic levels and technical skills with the welfare of the student as their chief consideration;

Therefore be it resolved that we support the administration and passage of the budget as presented for the coming election.

Millikin, speaking for the summer faculty members, asked the board not to delay summer school which is scheduled to start on June 22, two days before the election. Millikin said that the instructors would teach, "on the come," meaning without pay if necessary if the budget doesn't pass. He said that about 400 students were ready to start summer school and it would not be fair to them to delay or discontinue the summer session.

**POBANZ VIEWS DIFFER**

It appears to me that this community is basically proud of TVCC, and that the recent vote was not primarily against the budget.

"I believe, from my own conversations, that there are nine or ten items to be considered as important in the community thinking. The board cannot do much, or anything, about some of these, such as taxation generally, certain inevitable expenditures, the complexion of the student population, and the geographic sources of students.

"However, the board does have the power to accept the resignations of four or five administrators found objectionable by the community; it does have the power to encourage better public relations efforts by college personnel;

"It does have the power to alter the budget though it has seemed sound; it does have the power to modify the emphasis on athletics; and it probably can exert larger influence on salary levels."

**PERSONAL**

Following the reading of the statement, Pobanz received a mild round of applause from the crowd, the first such reaction during the night.

Chairman Saito made no comment, or asked for any, following Pobanz' reading of the statement.

It is now 10:30 p.m., the meeting has been in session for two and one-half hours, and there being no more questions, it is adjourned.

Some thirty minutes later the board went into session lasting until 2:30 the following morning and came up with another budget for submittal to the voters June 24. A brief summary of it is covered in another story in this issue of the Journal.

**Military Double Standard**

Senator Henry M. Jackson, of Washington, writing in the June 1969, issue of Reader's Digest makes some interesting observations on our relations with the Soviet Union.

The article details some of the myths involved in our relations with the Kremlin, but the most interesting of all is the arms race. Sen. Jackson, by virtue of membership on the key Armed Services Committee, is well versed in the deployment of both our own military forces and those of Russia.

He makes the point that the more vocal opponents of the Nixon proposal for an ABM Safeguard system are operating under a double standard. The senator writes: "I have never heard one of these critics say that in deploying its ABM system some years ago the Soviets were 'escalating the arms race.' There is a clear double standard here, and I am confident that the American people, once they have the facts, will recognize it as a standard that is crudely biased against our own country."

The senator offers in evidence the following:

"The Soviet Union acted first to develop ICBMs.

"The Soviet Union has developed and tested a 60-megaton bomb; it is the only nation to possess a terror weapon of anything like that size.

"The Soviet Union is the only nation to have built and installed ICBMs of the SS-9 size and to be testing multiple warheads on it.

"The Soviet Union has developed and tested a Fractional Orbital Bombardment System (FOBS), a first-strike-oriented weapon; it is the only nation to have available such an orbital weapon.

"The Soviet Union — in 1962 — test fired an anti-ballistic missile (ABM) against an incoming nuclear-armed missile; it is the only nation to have conducted such a test.

"The Soviet Union acted first to deploy ABMs, is installing more than 60 ABM launchers, and is testing an improved model — whereas the United States has not yet deployed ABMs of any kind."

Sen. Jackson is a Democrat who places his nation's security above partisanship. His arguments appear to be substantial. It might serve the cause of national defense if all of the critics of the Safeguard ABM system and the constant apologists for the Soviet Union would take the few minutes necessary to read the senator's remarks. They might well learn something. (Wash. Exclusive)
